

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approving FY 2025-2026 Gu Achi District American Rescue Plan Act Budget  
Amendment No. 1 to Extend Budget Period)**

**RESOLUTION NO. 24-420**

1 **WHEREAS,** pursuant to Article IX, Section 7 of the Constitution of the Tohono O'odham  
2 Nation,

3 No district council shall expend district funds except pursuant to budgets  
4 authorized under resolutions of the district council and approved by the  
5 Tohono O'odham Council. The management of these funds shall be only by  
6 a treasurer or other authorized officer of the district council who has  
7 furnished a surety bond satisfactory to the treasurer of the Tohono  
8 O'odham Nation, and all expenditures of these funds shall be by checks  
9 signed by such treasurer or other authorized officer and the chairman or  
10 vice chairman of the district council.

12 **WHEREAS,** the FY 2022-2024 Gu Achi District American Rescue Plan Act Budget in the amount  
13 of \$3,570,716.00 was authorized by Gu Achi District Council Resolution No. 1221-  
14 064 and approved by Legislative Council Resolution No. 22-263; and

15 **WHEREAS,** by Gu Achi District Council Resolution No. 1124-130, the Gu Achi District Council  
16 has authorized and submitted for review and approval its FY 2025-2026 Gu Achi  
17 District American Rescue Plan Act Budget Amendment No. 1, which is  
18 incorporated by this reference, and which will extend the budget period; and

19 **WHEREAS,** the FY 2025-2026 Gu Achi District American Rescue Plan Act Budget Amendment  
20 No. 1 will not change the original budget amount of \$3,570,716.00, but will extend  
21 the budget period ending on December 31, 2024 to December 31, 2026; and

22 **WHEREAS,** the Budget and Finance Committee has reviewed the FY 2025-2026 Gu Achi  
23 District American Rescue Plan Act Budget Amendment No. 1 and recommends its  
24 approval.

25 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council approves the  
26 FY 2025-2026 Gu Achi District American Rescue Plan Act Budget Amendment No.  
27 1 in the amount of \$3,570,716.00, effective March 11, 2021 and ending December  
28 31, 2026.

29 **BE IT FINALLY RESOLVED** by the Tohono O'odham Legislative Council that the FY 2025-2026 Gu  
30 Achi District American Rescue Plan Act Budget as amended shall be managed and  
31 expended in accordance with Article IX, Section 7 of the Constitution of the  
32 Tohono O'odham Nation and the Nation's laws, provided that any amendments or
