

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2025 Department of Health and Human Services Komckud Ki:
Family Violence Prevention Services Act Grant Budget)**

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**
2 **within the exclusive control of the Tohono O'odham Nation . . . and to appropriate**
3 **these funds for the benefit of the nation and its members" provided that "[a]ll**
4 **expenditures of these funds shall be pursuant to appropriations or budgets"**
5 **authorized by resolution or ordinance (Constitution of the Tohono O'odham**
6 **Nation, Article VI, Section 1(d)(2)); and**

7 **WHEREAS, the Department of Health and Human Services has prepared and submitted for**
8 **review and approval its FY 2025 Komckud Ki: Family Violence Prevention Services**
9 **Act Grant Budget, which is incorporated by this reference, in the amount of**
10 **\$303,047.00 to be funded by the Nation's general fund pending reimbursement by**
11 **the grantor, the Department of Health and Human Services Administration for**
12 **Children and Families; and**

13 **WHEREAS, the Health and Human Services and Budget and Finance Committees have**
14 **reviewed the FY 2025 Department of Health and Human Services Komckud Ki:**
15 **Family Violence Prevention Services Act Grant Budget and recommend its**
16 **approval.**

17 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**
18 **FY 2025 Department of Health and Human Services Komckud Ki: Family Violence**
19 **Prevention Services Act Grant Budget effective October 1, 2024 in the amount of**
20 **\$303,047.00 which shall be funded by the Nation's general fund pending**
21 **reimbursement from the grantor, the Department of Health and Human Services**
22 **Administration for Children and Families.**

23 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**
24 **Nation chairperson or any designated official is authorized to administer and**
25 **expend the FY 2025 Department of Health and Human Services Komckud Ki:**
26 **Family Violence Prevention Services Act Grant Budget, provided that any**
27 **amendments or modifications shall be submitted for prior approval by the**
28 **Tohono O'odham Legislative Council.**
