

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approving FY 2025-2027 Sells Alternative Rural Health Center Project I  
TONHC Design Budget)**

**RESOLUTION NO. 24-426**

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**  
2 **within the exclusive control of the Tohono O'odham Nation . . . and to appropriate**  
3 **these funds for the benefit of the nation and its members" provided that "[a]ll**  
4 **expenditures of these funds shall be pursuant to appropriations or budgets"**  
5 **authorized by resolution or ordinance (Constitution of the Tohono O'odham**  
6 **Nation, Article VI, Section 1(d)(2) and (3)); and**

7 **WHEREAS, the Tohono O'odham Nation Health Care ("TONHC") has prepared and submitted**  
8 **for review and approval its FY 2025-2027 Sells Alternative Rural Health Center**  
9 **Project I TONHC Design Budget, which is incorporated by this reference, in the**  
10 **amount of \$33,328,000.00 to be funded by the Indian Health Service ("IHS"); and**

11 **WHEREAS, IHS allows the use of funds until they have been fully expended, TONHC has**  
12 **prepared the FY 2025-2027 Sells Alternative Rural Health Center Project I TONHC**  
13 **Design Budget to expend funds for three years, effective October 1, 2024, through**  
14 **September 30, 2027; and**

15 **WHEREAS, the Health and Human Services and Budget and Finance Committees have**  
16 **reviewed these FY 2025-2027 Sells Alternative Rural Health Center Project I**  
17 **TONHC Design Budget and recommend approval.**

18 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**  
19 **FY 2025-2027 Sells Alternative Rural Health Center Project I TONHC Design**  
20 **Budget in the amount of \$33,328,000.00 effective October 1, 2024, through**  
21 **September 30, 2027, which shall be funded by a contract with the grantor, Indian**  
22 **Health Services.**


23 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**  
24 **Nation chairperson or any designated official is authorized to administer and**  
25 **expend the FY 2025-2027 Sells Alternative Rural Health Center Project I TONHC**  
26 **Design Budget provided that any amendments or modifications shall be**  
27 **submitted for prior approval by the Tohono O'odham Legislative Council.**

28 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 10<sup>TH</sup>**  
29 **day of DECEMBER 2024 at a meeting at which a quorum was present with a vote of 3,236.3 FOR;**  
30 **-0- AGAINST; -0- NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by**  
31 **Article VI, Section 1(d)(2) and (3) of the Constitution of the Tohono O'odham Nation, adopted by**  
32 **the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
33 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**  
34 **18, 1934 (48 Stat.984).**
