

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2025-2027 Sells Alternative Rural Health Center Project II TONHC
Water and Sewer Budget)**

RESOLUTION NO. 24-427

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**
2 **within the exclusive control of the Tohono O'odham Nation . . . and to appropriate**
3 **these funds for the benefit of the nation and its members" provided that "[a]ll**
4 **expenditures of these funds shall be pursuant to appropriations or budgets"**
5 **authorized by resolution or ordinance (Constitution of the Tohono O'odham**
6 **Nation, Article VI, Section 1(d)(2) and (3)); and**

7 **WHEREAS, the Tohono O'odham Nation Health Care ("TONHC") has prepared and submitted**
8 **for review and approval its FY 2025-2027 Sells Alternative Rural Health Center**
9 **Project II TONHC Water and Sewer Budget, which is incorporated by this**
10 **reference, in the amount of \$8,698,000.00 to be funded by the Indian Health**
11 **Service ("IHS"); and**

12 **WHEREAS, IHS allows the use of funds until they have been fully expended, TONHC has**
13 **prepared the FY 2025-2027 Sells Alternative Rural Health Center Project II TONHC**
14 **Water and Sewer Budget to expend funds for three years, effective October 1, 2024,**
15 **through September 30, 2027; and**

16 **WHEREAS, the Health and Human Services and Budget and Finance Committees have**
17 **reviewed these FY 2025-2027 Sells Alternative Rural Health Center Project II**
18 **TONHC Water and Sewer Budget and recommend approval.**

19 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**
20 **FY 2025-2027 Sells Alternative Rural Health Center Project II TONHC Water and**
21 **Sewer Budget in the amount of \$8,698,000.00 effective October 1, 2024, through**
22 **September 30, 2027, which shall be funded by a contract with the grantor, Indian**
23 **Health Services.**

24 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**
25 **Nation chairperson or any designated official is authorized to administer and**
26 **expend the FY 2025-2027 Sells Alternative Rural Health Center Project II TONHC**
27 **Water and Sewer Budget provided that any amendments or modifications shall**
28 **be submitted for prior approval by the Tohono O'odham Legislative Council.**


