

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2025-2026 Schuk Toak District American Rescue Plan Act Budget
Amendment No. 1 to Extend Budget Period)**

RESOLUTION NO. 24-431

1 **WHEREAS,** pursuant to Article IX, Section 7 of the Constitution of the Tohono O'odham
2 Nation,

3 No district council shall expend district funds except pursuant to budgets
4 authorized under resolutions of the district council and approved by the
5 Tohono O'odham Council. The management of these funds shall be only by
6 a treasurer or other authorized officer of the district council who has
7 furnished a surety bond satisfactory to the treasurer of the Tohono
8 O'odham Nation, and all expenditures of these funds shall be by checks
9 signed by such treasurer or other authorized officer and the chairman or
10 vice chairman of the district council.

12 **WHEREAS,** the FY 2021-2025 Schuk Toak District American Rescue Plan Act Budget in the
13 amount of \$2,442,446.00 was authorized by Schuk Toak District Council
14 Resolution No. ST-11-10-22-110 and approved by Legislative Council Resolution
15 No. 23-274; and

16 **WHEREAS,** by Schuk Toak District Council Resolution No. ST-12-03-24-124, the Schuk Toak
17 District Council has authorized and submitted for review and approval its FY
18 2025-2026 Schuk Toak District American Rescue Plan Act Budget Amendment No.
19 1 which is incorporated by this reference, and which will extend the budget
20 period; and

21 **WHEREAS,** the FY 2025-2026 Schuk Toak District American Rescue Plan Act Budget
22 Amendment No. 1 will not change the original budget amount of \$2,442,446.00,
23 but will extend the budget period ending on December 31, 2024 to December 31,
24 2026; and

25 **WHEREAS,** the Budget and Finance Committee has reviewed the FY 2025-2026 Schuk Toak
26 District American Rescue Plan Act Budget Amendment No. 1 and recommends its
27 approval.

28 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council approves the
29 FY 2025-2026 Schuk Toak District American Rescue Plan Act Budget Amendment
30 No. 1 in the amount of \$2,442,446.00, effective March 11, 2021 and ending
31 December 31, 2026.



2 **Schuk Toak District American Rescue Plan Act Budget** as amended shall be
3 **managed and expended in accordance with Article IX, Section 7 of the**
4 **Constitution of the Tohono O'odham Nation and the Nation's laws, provided that**
5 **any amendments or modifications shall be authorized under District Council**
6 **resolution and submitted for prior approval by the Tohono O'odham Legislative**
7 **Council.**

8 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 11TH**
9 **day of DECEMBER 2024 at a meeting at which a quorum was present with a vote of 3,263.3 FOR;**
10 **-0- AGAINST; -0- NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by**
11 **Article IX, Sections 1(f) of the Constitution of the Tohono O'odham Nation, adopted by the**
12 **Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
13 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
14 **18, 1934 (48 Stat.984).**




