

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2022-2027 Sells District American Rescue Plan Act Budget
Amendment No. 1 to Extend Budget Period)**

RESOLUTION NO. 24-432

1 **WHEREAS,** pursuant to Article IX, Section 7 of the Constitution of the Tohono O'odham
2 Nation,

3 No district council shall expend district funds except pursuant to budgets
4 authorized under resolutions of the district council and approved by the
5 Tohono O'odham Council. The management of these funds shall be only by
6 a treasurer or other authorized officer of the district council who has
7 furnished a surety bond satisfactory to the treasurer of the Tohono O'odham
8 Nation, and all expenditures of these funds shall be by checks signed by such
9 treasurer or other authorized officer and the chairman or vice chairman of
10 the district council.

12 **WHEREAS,** the FY 2022-2024 Sells District American Rescue Plan Act Budget in the amount of
13 \$7,135,021.00 was authorized by Sells District Council Resolution No. SD-67-23
14 and approved by Legislative Council Resolution No. 23-196; and

15 **WHEREAS,** by Sells District Council Resolution No. SD-24-25, the Sells District has authorized
16 and submitted for review and approval its FY 2022-2027 Sells District American
17 Rescue Plan Act Budget Amendment No. 1, which is incorporated by this
18 reference to extend the budget period ; and

19 **WHEREAS,** the FY 2022-2027 Sells District American Rescue Plan Act Budget Amendment No.
20 1 will not change the total budget amount of \$7,135,021.00 but will extend the
21 budget period to December 31, 2026; and

22 **WHEREAS,** the Budget and Finance Committee has reviewed the FY 2022-2027 Sells District
23 American Rescue Plan Act Budget Amendment No. 1 and recommends its
24 approval.

25 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council approves the
26 FY 2022-2027 Sells District American Rescue Plan Act Budget Amendment No. 1 in
27 the amount of \$7,135,021.00 effective October 1, 2021 and ending December 31,
28 2026.

29 **BE IT FINALLY RESOLVED** by the Tohono O'odham Legislative Council that the FY 2022-2027 Sells
30 District American Rescue Plan Act Budget as amended shall be managed and
31 expended in accordance with Article IX, Section 7 of the Constitution of the
32 Tohono O'odham Nation and the Nation's laws, provided that any amendments or

modifications shall be authorized under District Council resolution and submitted for prior approval by the Tohono O'odham Legislative Council.

The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 11TH day of DECEMBER 2024 at a meeting at which a quorum was present with a vote of 3,263.3 FOR; -0- AGAINST; -0- NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by Article IX, Section 7 of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat.984).
