

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2025 Department of Health and Human Services Division of Senior
Services Program Title III Budgets Amendments No. 1)**

RESOLUTION NO. 25-013

1 **WHEREAS,** the Tohono O'odham Legislative Council is authorized "to manage any funds
2 within the exclusive control of the Tohono O'odham Nation . . . and to appropriate
3 these funds for the benefit of the nation and its members" provided that "[a]ll
4 expenditures of these funds shall be pursuant to appropriations or budgets"
5 authorized by resolution or ordinance (Constitution of the Tohono O'odham
6 Nation, Article VI, Section 1(d) (2)); and

7 **WHEREAS,** the FY 2025 Department of Health and Human Services Senior Services Program
8 Title III Budgets (consisting of Title III B Transportation Budget, Title III C-1
9 Congregate Budget, Title III C-2 Home Delivered Meals Budget and other items)
10 in the amount of \$111,600.00 were approved by Resolution No. 24-181; and

11 **WHEREAS,** the Department of Health and Human Services Senior Services Program has
12 prepared and submitted for review and approval its FY 2025 Department of
13 Health and Human Services Senior Services Program Title III Budgets
14 Amendments No. 1, which are incorporated by this reference and which will
15 adjust operational line items; and

16 **WHEREAS,** the FY 2025 Department of Health and Human Services Senior Services Program
17 Title III Budgets Amendments No. 1 will increase Senior Services Program Title III
18 FY 2025 Budgets by \$741.00 from \$111,600.00 to \$112,341.00 (increasing the Title
19 III B Transportation Budget by \$2,000.00 from \$18,000.00 to \$20,000.00,
20 decreasing the Title III C-1 Congregate Budget by \$2,259.00 from \$41,600.00 to
21 \$39,341.00, increasing the Title III C-2 Home Delivered Meals Budget by \$1,000.00
22 from \$41,000.00 to \$42,000.00); and

23 **WHEREAS,** the Health and Human Services and Budget and Finance Committees have
24 reviewed the FY 2025 Department of Health and Human Services Senior Services
25 Program Title III Budgets Amendments No. 1 and recommend their approval.

26 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council approves the
27 FY 2025 Department of Health and Human Services Senior Services Program Title
28 III Budgets Amendments No. 1 effective July 1, 2024, which includes an overall
29 increase from \$111,600.00 to \$112,341.00 to be funded by the Nation's general
30 fund pending reimbursement by the grantor, Title III of the Older Americans Act
31 through the Inter-Tribal Council of Arizona as follows:

1. Title III B Transportation Budget will increase by \$2,000.00 from \$18,000.00 to \$20,000.00.
2. Title III C-1 Congregate Budget will decrease by \$2,259.00 from \$41,600.00 to \$39,341.00.
3. Title III C-2 Home Delivered Meals Budget will increase by \$1,000.00 from \$41,000.00 to \$ 42,000.00.

BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham Nation chairperson or any designated official is authorized to administer and expend the FY 2025 Department of Health and Human Services Senior Services Program Title III Budgets as amended; provided that any amendments or modifications shall be submitted for prior approval by the Tohono O'odham Legislative Council.

The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 14TH day of JANUARY 2025 at a meeting at which a quorum was present with a vote of 3,263.3 FOR; -0- AGAINST; -0- NOT VOTING; and [04] ABSENT, pursuant to the powers vested in the Council by Article VI, Section 1(d)(2)and(3)of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat.984).






