

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2025 Department of Natural Resources Wildlife and Vegetation
Management Program Tribal Wildlife Grant Budget Amendment No. 1)**

RESOLUTION NO. 25-014

1 **WHEREAS,** the Tohono O'odham Legislative Council is authorized "to manage any funds
2 within the exclusive control of the Tohono O'odham Nation . . . and to appropriate
3 these funds for the benefit of the nation and its members" provided that "[a]ll
4 expenditures of these funds shall be pursuant to appropriations or budgets"
5 authorized by resolution or ordinance (Constitution of the Tohono O'odham
6 Nation, Article VI, Sections 1(d)(2)) and 1(d)(3); and

7 **WHEREAS,** on July 14, 2023, Legislative Council passed Res. No. 23-263 accepting the U.S. Fish
8 and Wildlife Service Tribal Wildlife Grant No. F22AP01262-00 ("U.S. Fish and
9 Wildlife Service Tribal Wildlife Grant"), which allocated \$200,000.00 to the
10 Department of Natural Resources Wildlife and Vegetation Management Program
11 to study the distributional ecology of medium and large mammals, and
12 approving the FY 2023–FY 2024 Department of Natural Resources Wildlife and
13 Vegetation Management Program Tribal Wildlife Grant Budget ("FY 2023–FY 2024
14 Grant Budget") in the amount of \$200,000.00; and

15 **WHEREAS,** on June 25, 2024, Legislative Council passed Res. No. 24-183 approving the
16 extension of the FY 2023–FY 2024 Grant Budget through FY 2026; and

17 **WHEREAS,** the Department of Natural Resources Wildlife and Vegetation Management
18 Program has prepared and submitted for review and approval its FY 2025 Budget
19 Amendment No. 1, which is incorporated by this reference and which will adjust
20 operational and personnel line items; and

21 **WHEREAS** the FY 2025 Department of Natural Resources Wildlife and Vegetation
22 Management Program Tribal Wildlife Grant Budget Amendment No. 1 will not
23 change the original budget amount of \$200,000.00; and

24 **WHEREAS,** the Agricultural and Natural Resource Committee and Budget and Finance
25 Committee have reviewed the FY 2025 Department of Natural Resources Wildlife
26 and Vegetation Management Program Tribal Wildlife Grant Budget Amendment
27 No. 1 and recommend its approval.

28 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council approves the
29 FY 2025 Department of Natural Resources Wildlife and Vegetation Management
30 Program Tribal Wildlife Grant Budget Amendment No. 1 effective October 1, 2024,
31 which does not change the original budget amount of \$200,000.00 and shall be
32 funded by the U.S. Fish and Wildlife Service Tribal Wildlife Grant.



1 **BE IT FINALLY RESOLVED** by the Tohono O'odham Legislative Council that the Tohono O'odham
2 Nation chairperson or any designated official is authorized to administer and
3 expend the FY 2025 Department of Natural Resource Department Wildlife and
4 Vegetation Management Program Tribal Wildlife Grant Budget as amended,
5 provided that any amendments or modifications shall be submitted for prior
6 approval by the Tohono O'odham Legislative Council.

7 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 14TH
8 day of JANUARY 2025 at a meeting at which a quorum was present with a vote of 3,263.3 FOR;
9 -0- AGAINST; -0- NOT VOTING; and [05] ABSENT, pursuant to the powers vested in the Council by
10 Article VI, Section 1(d)(2)and(3) of the Constitution of the Tohono O'odham Nation, adopted by
11 the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant
12 Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June
13 18, 1934 (48 Stat.984).




