

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Approving a No Cost Extension to the FY 2024-2025 Planning and Economic Development**  
**Department Roads Program Bureau of Indian Affairs Allocated Gu Vo Loop Road Project**  
**PIR 1006(1) Budget Amendment No. 2)**

**RESOLUTION NO. 25-015**

1 **WHEREAS,** the Tohono O'odham Legislative Council is authorized "to manage any funds  
2 within the exclusive control of the Tohono O'odham Nation . . . and to appropriate  
3 these funds for the benefits of the nation and its members" provided that "(a)ll  
4 expenditures of these funds shall be pursuant to appropriations or budgets"  
5 authorized by resolution or ordinance (Constitution of the Tohono O'odham  
6 Nation, Article VI, Section 1(d)(2)); and

7 **WHEREAS,** the FY 2021 Planning and Economic Development Department Roads Program Gu  
8 Vo Loop Road Project PIR 1006 (1) Budget in the amount of \$104,107.21 was  
9 approved by Resolution No. 21-329; and

10 **WHEREAS,** the BIA Western Region Office awarded the Nation an additional \$1,609,049.76 for  
11 the Planning and Economic Development Department Roads Program Gu Vo  
12 Loop Road Project PIR 1006 (1) for construction activities; and

13 **WHEREAS,** the FY 2022 Planning and Economic Development Department Roads Program Gu  
14 Vo Loop Road Project PIR 1006 (1) Budget Amendment No. 1, which increased the  
15 budget by \$1,609,049.76 from \$104,107.21 to \$1,713,156.97 was approved by  
16 Resolution 22-018; and

17 **WHEREAS,** the budget authority under Resolution No. 22-018 expired on September 30, 2023;  
18 and

19 **WHEREAS,** the Planning and Economic Development Department Roads Program has  
20 received a no cost extension notice from the Bureau of Indian Affairs via  
21 Modification No. 10 to extend the FY 2024-2025 Gu Vo loop Road Project PIR1006  
22 (1) budget period of performance through September 30, 2025; and

23 **WHEREAS,** the Agricultural and Natural Resources and Budget and Finance Committees  
24 have reviewed budget FY 2024-2025 Planning and Economic Development  
25 Department Roads Program Bureau of Indian Affairs Allocated Gu Vo Loop Road  
26 Project PIR 1006(1) Budget Amendment No. 2 in the amount of \$1,628,569.80 and  
27 recommend its approval.

28 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council approves the  
29 no cost extension for FY 2024-2025 Planning and Economic Development  
30 Department Roads Program Gu Vo Loop Road PIR 1006(1) Budget Amendment No.  
31 2 in the amount of \$1,628,569.80.

2 Nation chairperson or any designated official is authorized to administer and  
3 expend the FY 2024 Planning and Economic Development Department Roads  
4 Program Gu Vo Loop Road PIR 1006(1) Budget Amendment No. 2, provided that  
5 any amendments or modifications shall be submitted for prior approval by the  
6 Tohono O'odham Legislative Council.

7 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 14<sup>TH</sup>  
8 day of JANUARY 2025 at a meeting at which a quorum was present with a vote of 3,263.30 FOR;  
9 -0- AGAINST; -0- NOT VOTING; and [05] ABSENT, pursuant to the powers vested in the Council by  
10 Article VI, Section 1(d)(2) of the Constitution of the Tohono O'odham Nation, adopted by the  
11 Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant  
12 Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June  
13 18, 1934 (48 Stat.984).






