

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2025-2027 Legislative Branch Legislative Replacement Building
Supplemental Budget)**

RESOLUTION NO. 25-017

1 **WHEREAS,** the Tohono O'odham Legislative Council is authorized "to manage any funds
2 within the exclusive control of the Tohono O'odham Nation . . . and to appropriate
3 these funds for the benefit of the nation and its members" provided that "[a]ll
4 expenditures of these funds shall be pursuant to appropriations or budgets"
5 authorized by resolution or ordinance (Constitution of the Tohono O'odham
6 Nation, Article VI, Section 1(d)(2)); and

7 **WHEREAS,** by Resolution No. 21-292, the Tohono O'odham Legislative Council adopted the
8 Tohono O'odham Nation American Rescue Plan Act ("ARPA") Allocation Plan; and

9 **WHEREAS,** the ARPA Allocation Plan includes \$19,000,000.00 for the Tohono O'odham
10 Legislative Branch; and

11 **WHEREAS,** the FY 2022-FY 2025 Legislative Branch American Rescue Plan Act Budget in the
12 amount of \$19,000,000.00 was approved by Legislative Council Resolution No. 22-
13 311 and subsequently amended by Resolution No. 24-362; and

14 **WHEREAS,** the American Rescue Plan Act requires funds to be obligated by December 31,
15 2024 and gives an additional two years for completion of projects and/or delivery
16 of services by December 31, 2026; and

17 **WHEREAS,** the Legislative Branch has prepared and submitted for review and approval its FY
18 2025-2027 Legislative Replacement Building Supplemental Budget in the amount
19 of \$21,979,004.47, which is incorporated by this reference; and

20 **WHEREAS,** the Budget and Finance Committee has reviewed the FY 2025-2027 Legislative
21 Branch Legislative Replacement Building Supplemental Budget and
22 recommends its approval.

23 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council approves the
24 FY 2025-2027 Legislative Branch Legislative Replacement Building Supplemental
25 Budget effective October 1, 2024 through September 30, 2027, in the amount of
26 \$21,979,004.47, which shall be funded by Nation's general fund surplus.

27 **BE IT FINALLY RESOLVED** by the Tohono O'odham Legislative Council that the Tohono O'odham
28 Legislative Council chairperson or any designated official is authorized to
29 administer and expend the FY 2025-2027 Legislative Branch Legislative
30 Replacement Building Supplemental Budget, provided that any modifications
31 shall be submitted to the Budget and Finance Committee for approval on behalf



Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the
Act of June 18, 1934 (48 Stat.984).


