

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving Professional Service Agreement Between the Tohono O'odham Legislative
Branch and AXIOS Builders LLC for Temporary Modular Office Building)**

RESOLUTION NO. 25-018

1 **WHEREAS, the Constitution of the Tohono O'odham Nation vests the Legislative Council with**
2 **the power to “negotiate and conclude agreements and contracts on behalf of the**
3 **Tohono O'odham Nation . . . with private persons or organizations on all matters**
4 **within the authority of the Tohono O'odham Council” (Constitution, Article VI,**
5 **Section 1(f)); and**

6 **WHEREAS, the Council has prescribed the duties and powers of the Council chairperson and**
7 **vice chairperson by adopting the Legislative Rules and by passing Legislative**
8 **Order No. 06-047, “Amended Delegation of Authority to Legislative Council**
9 **Chairperson and Vice Chairperson,” which vests the Council chairperson with**
10 **contracting authority subject to specified limitations (Constitution, Article V,**
11 **Section 4); and**

12 **WHEREAS, 26 T.O.C. Chapter 1, Article 4, Section 1405 also vests the Legislative Council**
13 **chairperson with the authority to negotiate, execute, and conclude contracts that**
14 **expend funds pursuant to appropriations or budgets authorized by resolution**
15 **that are within the authorities the Legislative Council has delegated to the**
16 **Council chairperson, and in amounts not to exceed \$100,000.00; and**

17 **WHEREAS, the Legislative Council by Resolution No. 22-311 approved the FY 2022 Legislative**
18 **Branch ARPA Budget, which has been amended and extended through December**
19 **31, 2026 by Resolution No. 24-362 as the FY 2025-2027 Legislative Branch ARPA**
20 **Funding Budget, and which includes funding to cover costs associated with the**
21 **construction of the Legislative Branch replacement building; and**

22 **WHEREAS, the Legislative Council chairperson has selected AXIOS Builders LLC to purchase,**
23 **deliver, and install a Legislative Branch temporary modular office building with**
24 **utilities in Sells, Arizona; and**

25 **WHEREAS, the Professional Service Agreement Between the Tohono O'odham Legislative**
26 **Branch and AXIOS Builders LLC for the temporary modular office building (“the**
27 **Agreement”), which is incorporated by this reference, is for an amount not to**
28 **exceed \$509,283.85 and therefore requires Legislative Council approval; and**

29 **WHEREAS, the Legislative Council officers have reviewed the Agreement and recommend its**
30 **approval.**



1 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**
2 **Agreement Between the Tohono O'odham Legislative Branch and AXIOS Builders**
3 **LLC in substantially the form presented to the Legislative Council and in an**
4 **amount not to exceed \$509,283.85, which shall be funded by the FY 2025-2027**
5 **Legislative Branch ARPA Funding Budget.**

6 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council authorizes the**
7 **Legislative Council chairperson to execute the Agreement Between the Tohono**
8 **O'odham Legislative Branch and AXIOS Builders LLC.**


9 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 14TH**

12 **by Article VI, Section 1(f) Article V, Section 4 of the Constitution of the Tohono O'odham Nation,**
13 **adopted by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy**
14 **Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the**
15 **Act of June 18, 1934 (48 Stat.984).**






