

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approving FY 2025 Sells District North Communities INT-01-14 Budget)**

**RESOLUTION NO. 25-020**

1 **WHEREAS,** pursuant to Article IX, Section 7 of the Constitution of the Tohono O'odham  
2 **Nation,**

3  
4 **No district council shall expend district funds except pursuant to budgets**  
5 **authorized under resolutions of the district council and approved by the**  
6 **Tohono O'odham Council. The management of these funds shall be only by**  
7 **a treasurer or other authorized officer of the district council who has**  
8 **furnished a surety bond satisfactory to the treasurer of the Tohono**  
9 **O'odham Nation, and all expenditures of these funds shall be by checks**  
10 **signed by such treasurer or other authorized officer and the chairman or**  
11 **vice chairman of the district council.**

12 **; and**

13 **WHEREAS,** by Sells District Council Resolution No. SD-13-25, the Sells District has authorized  
14 **the FY 2025 Sells District North Communities INT-01-14 Budget, which is**  
15 **incorporated by this reference, in the amount of \$1,553.98; and**

16 **WHEREAS,** the Budget and Finance Committee has reviewed the FY 2025 Sells District North  
17 **Communities INT-01-14 Budget and recommends its approval.**


18 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council approves the  
19 **FY 2025 Sells District North Communities INT Budget effective October 1, 2024 in**  
20 **the amount of \$1,553.98, which shall be funded by FY 2024 North Communities**  
21 **INT-01-14 Budget carry over funds.**

22 **BE IT FINALLY RESOLVED** by the Tohono O'odham Legislative Council that the FY 2025 Sells  
23 **District North Communities INT-01-14 Budget shall be managed and expended in**  
24 **accordance with Article IX, Section 7 of the Constitution of the Tohono O'odham**  
25 **Nation and the Nation's laws, provided that any amendments or modifications**  
26 **shall be authorized under District Council resolution and submitted for prior**  
27 **approval by the Tohono O'odham Legislative Council.**


28 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 16<sup>TH</sup>**  
29 **day of JANUARY 2025 at a meeting at which a quorum was present with a vote of 3,016.2 FOR; -0-**  
30 **AGAINST; -0- NOT VOTING; and 247.1 [02] ABSENT, pursuant to the powers vested in the Council**  
31 **by Article XI, Section 7 of the Constitution of the Tohono O'odham Nation, adopted by the**  
32 **Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
33 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**  
34 **18, 1934 (48 Stat.984).**




