

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Amending Enrollment Resolution Nos. 162-82, 27-84, 142-89, 99-475, 05-301, 06-787,
07-075, 07-112, 07-236, 09-066, 11-229, 11-362, 12-001 and 14-001 to Correct Names
and/or Enrollment Numbers of Enrolled Members)**

RESOLUTION NO. 25-028

1 **WHEREAS,** the Tohono O'odham Legislative Council is vested with the power to enact laws
2 and ordinances governing the enrollment and adoption of members
3 (Constitution of the Tohono O'odham Nation, Article II, Sections 1 and 2 and
4 Article VI, Section 1(b)); and

5 **WHEREAS,** pursuant to Article VI and VII of the Nation's Enrollment Ordinance, the
6 Enrollment Committee shall review membership applications and make a
7 written recommendation to the Tohono O'odham Legislative Council to approve
8 or reject the application (14 Tohono O'odham Code Chapter 1 - Enrollment
9 Ordinance); and

10 **WHEREAS,** pursuant to Article VIII of the Nation's Enrollment Ordinance, the Tohono
11 O'odham Legislative Council shall determine eligibility for membership or
12 adoption; and

13 **WHEREAS,** the Enrollment Program has determined that a number of resolutions approving
14 membership and adoption applications misspelled or incorrectly listed the
15 names of members and/or incorrectly listed enrollment numbers; and

16 **WHEREAS,** the Enrollment Committee recommends that Resolution Nos. 162-82, 27-84, 142-
17 89, 99-475, 05-301, 06-787, 07-075, 07-112, 07-236, 09-066, 11-229, 11-362, 12-001
18 and 14-001 be amended to reflect the correct name and/or enrollment number
19 for the members identified in the February 2025 Corrected Enrollment
20 Resolution Summary, which is incorporated by this reference.

21 **NOW, THEREFORE, BE IT RESOLVED** by the Tohono O'odham Legislative Council that Resolution
22 Nos. 162-82, 27-84, 142-89, 99-475, 05-301, 06-787, 07-075, 07-112, 07-236, 09-066,
23 11-229, 11-362, 12-001 and 14-001 are amended upon the effective date of those
24 resolutions to reflect the correct names and/or enrollment number of members
25 identified in the February 2025 Corrected Enrollment Resolution Summary.

26 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 10TH**
27 **day of FEBRUARY 2025 at a meeting at which a quorum was present with a vote of 3,263.3 FOR;**
28 **-0- AGAINST; -0- NOT VOTING; and -0- ABSENT, pursuant to the powers vested in the Council by**
29 **Article II, Sections 1 and 2 and Article VI, Section 1(h) of the Constitution of the Tohono O'odham**
30 **Nation, adopted by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting**
31 **Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section**
32 **16 of the Act of June 18, 1934 (48 Stat.984).**
