

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Amending Enrollment Resolution No. 06-261 "Approving Enrollment Applications
for Membership into the Tohono O'odham Nation for May 2006,"
to Delete Member who was Approved Twice)**

RESOLUTION NO. 25-029

1 **WHEREAS, the Tohono O'odham Legislative Council is vested with the power to enact laws**
2 **and ordinances governing the enrollment and adoption of members**
3 **(Constitution of the Tohono O'odham Nation, Article VI, Section 1(h); and**

4 **WHEREAS, Articles VI and VII of the Nation's Enrollment Ordinance provide that the**
5 **Enrollment Committee is responsible for reviewing enrollment applications and**
6 **making recommendations to the Legislative Council regarding the eligibility of**
7 **applicants (Ordinance No. 05-81, as amended; 14 T.O.C. Chapter 1); and**

8 **WHEREAS, the Enrollment Program has determined that a member was originally approved**
9 **for membership by Resolution No. 05-002 and was mistakenly approved a second**
10 **time for membership by Resolution No. 06-261; and**

11 **WHEREAS, the Enrollment Committee recommends that Resolution No. 06-261 be amended**
12 **to delete the member identified in the attached Amending Enrollment Resolution**
13 **List for May 2006.**

14 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that Resolution**
15 **No. 06-261, "Approving Enrollment or Adoption Applications for Membership into**
16 **the Tohono O'odham Nation for May 2006," is amended upon effective date of that**
17 **resolution to delete the member and corresponding information identified in the**
18 **attached Amending Enrollment Resolution List for February 2025 and the**
19 **member identified therein shall retain the roll number and approval date**
20 **identified in that resolution.**

21 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 10TH**
22 **day of FEBRUARY 2025 at a meeting at which a quorum was present with a vote of 3,263.3 FOR;**
23 **-0- AGAINST; -0- NOT VOTING; and -0- ABSENT, pursuant to the powers vested in the Council by**
24 **Article II, Sections 1 and 2 and Article VI, Section 1(h) of the Constitution of the Tohono O'odham**
25 **Nation, adopted by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting**
26 **Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section**
27 **16 of the Act of June 18, 1934 (48 Stat.984).**
