20		Plan Act Budget, which includes funding to cover all costs associated with the				
21		construction of the Legislative Branch replacement building; and				
22	WHEREAS,	the Legislative Council by Resolution No. 24-264 approved the Agreement				
23		Between the Tohono O'odham Legislative Branch and Axios Builders LLC ("the				
24		Agreement") for the demolition of the existing Tohono O'odham Legislative				
25		Building; and				
26	WHEREAS,	the Legislative Council chairperson has submitted for review and approval				
27		Amendment No. I to the Agreement extending the end date to June 27, 2025, which				
28		is incorporated by this reference; and				
29	WHEREAS,	the Legislative Council chairperson has reviewed Amendment No. 1 to the				
30		Agreement and recommends approval.
