1	WHEREAS,	the Constitution of the Tohono O'odham Nation vests the Legislative Council with
2		the authority to "promote, protect and provide for public health and general
3		welfare of the Tohono O'odham Nation and its members" and to "consult with the
4		Congress of the United States and appropriate federal agencies regarding federal
5		activities that affect the Tohono O'odham Nation" (Constitution, Article VI,
6		Section 1(c)(2) and Section 1(j)); and
7	WHEREAS,	the U.S. Department of Health and Human Services ("HHS") Secretary's Tribal
8		Advisory Committee ("STAC"), established in 2010, represents the highest level
9		tribal advisory committee in the HHS and is intended as a forum for government-
10		to-government consultation; and
11	WHEREAS,	the STAC's primary purpose is to identify issues and priorities, seek consensus,
12		exchange views, share information, provide advice and recommendations, and
13		coordinate with HHS agencies on all matters related to improving health and
14		human services and ensuring tribal consultation on HHS policies affecting
15		American Indian and Alaska Native communities; and
16	WHEREAS,	the STAC's tribal representation is comprised of 17 positions filled by voluntary
17		representatives: one delegate (and one alternate) from each of the 12 Indian
18		Health Service ("IHS") areas and one delegate (and one alternate) for five National
19		At-Large Tribal Member positions; and
20	WHEREAS,	by Resolution No. 23-379, the Legislative Council reaffirmed the appointment of
21		Representative Daniel L.A. Preston, III as the STAC Tucson Area delegate and
22		nominated Representative Pamela J. Benavidez as alternate; and
23	WHEREAS,	Representative Daniel L.A. Preston, III and Representative Pamela J. Benavidez
24		have served as the STAC Tucson Area delegate and alternate, however, their terms
25		bave expired; and
26	WHEREAS,	the Health and Human Services Committee recommends the nominations of
27		Representative Daniel L.A. Preston, III and Representative Pamela J. Benavidez
28		to continue to serve as the STAC Tucson Area delegate and alternate.
29	NOW, THER	EFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council nominates
30		Representative Daniel L. A. Preston, III to serve as Tucson Area delegate and
