

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2022 Planning and Economic Development Department Roads
Program PIR Road Maintenance Budget Amendment No. 2)**

RESOLUTION NO. 25-044

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**
2 **within the exclusive control of the Tohono O'odham Nation . . . and to appropriate**
3 **these funds for the benefit of the nation and its members" provided that "[a]ll**
4 **expenditures of these funds shall be pursuant to appropriations or budgets"**
5 **authorized by resolution or ordinance (Constitution of the Tohono O'odham**
6 **Nation, Article VI, Section 1(d)(2)); and**

7 **WHEREAS, the FY 2022 Planning and Economic Development Department Roads Program**
8 **PIR Road Maintenance Budget in the amount of \$4,655,408.59 was approved by**
9 **Resolution No. 22-242, and subsequently amended by Resolution No. 22-428; and**

10 **WHEREAS, the Planning and Economic Development Department Roads Program has**
11 **prepared and submitted for review and approval its FY 2022 Planning and**
12 **Economic Development Department Roads Program PIR Road Maintenance**
13 **Budget Amendment No. 2, which is incorporated by this reference and which will**
14 **adjust operational line items; and**

15 **WHEREAS, the Planning and Economic Development Department Roads Program Budget**
16 **Amendment No. 2 will increase the FY 2022 Planning and Economic Development**
17 **Department Roads Program PIR Road Maintenance Budget by \$1,840,866.75 from**
18 **\$6,507,077.59 to \$8,347,944.34; and**

19 **WHEREAS, the Agricultural and Natural Resources and Budget and Finance Committees**
20 **have reviewed the FY 2022 Planning and Economic Development Department**
21 **Roads Program PIR Road Maintenance Budget Amendment No. 2 and**
22 **recommends its approval.**

23 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**
24 **FY 2022 Planning and Economic Development Department Roads Program PIR**
25 **Road Maintenance Budget Amendment No. 2, effective May 16, 2022 and ending**
26 **September 30, 2025, which includes a \$1,840,866.75 increase from \$6,507,077.59**
27 **to \$8,347,944.34 that shall be funded by the Nation's general fund pending**
28 **reimbursement by the grantor, the Bureau of Indian Affairs.**

29 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council authorizes the Tohono**
30 **O'odham Nation chairperson or any designated official to expend and administer**
31 **the budget, provided that any amendments or modifications shall be submitted**
32 **for prior approval by the Tohono O'odham Legislative Council.**


