

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2025 Baboquivari District – Artesia/Little Tucson Community
Budget Amendment No. 1)**

RESOLUTION NO. 25-052

1 **WHEREAS,** pursuant to Article IX, Section 7 of the Constitution of the Tohono O'odham
2 Nation,

3 No district council shall expend district funds except pursuant to budgets
4 authorized under resolutions of the district council and approved by the
5 Tohono O'odham Council. The management of these funds shall be only by
6 a treasurer or other authorized officer of the district council who has
7 furnished a surety bond satisfactory to the treasurer of the Tohono
8 O'odham Nation, and all expenditures of these funds shall be by checks
9 signed by such treasurer or other authorized officer and the chairman or
10 vice chairman of the district council.

12 **WHEREAS,** the FY 2025 Baboquivari District – Artesia/Little Tucson Community Budget in the
13 amount of \$548,404.54 was authorized by Baboquivari District Council
14 Resolution No. 2024-B-77 and approved by Legislative Council Resolution No. 24-
15 325; and

16 **WHEREAS,** by Baboquivari District Council Resolution No. 2025-B-14, the Baboquivari
17 District has authorized and submitted for review and approval its FY 2025
18 Baboquivari District – Artesia/Little Tucson Community Budget Amendment No.
19 1, which is incorporated by this reference and which will adjust personnel and/or
20 operational line items; and

21 **WHEREAS,** the FY 2025 Baboquivari District – Artesia/Little Tucson Community Budget
22 Amendment No. 1 will not change the FY 2025 Baboquivari District – Artesia/Little
23 Tucson Community Budget amount of \$548,404.54; and

24 **WHEREAS,** the Budget and Finance Committee has reviewed the FY 2025 Baboquivari District
25 – Artesia/Little Tucson Community Budget Amendment No. 1 and recommends its
26 approval.

27 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council approves the
28 FY 2025 Baboquivari District – Artesia/Little Tucson Community Budget
29 Amendment No. 1, effective October 1, 2024, which will not change the FY 2025
30 Baboquivari District – Artesia/Little Tucson Community Budget amount of
31 \$548,404.54 nor will it change the FY 2025 Baboquivari District Budget amount of
32 \$4,735,610.33.



1 BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the FY 2025
2 Baboquivari District - Artesia/Little Tucson Community Budget as amended shall
3 be managed and expended in accordance with Article IX, Section 7 of the
4 Constitution of the Tohono O'odham Nation and the Nation's laws, provided that
5 any amendment or modifications shall be authorized under District Council
6 resolution and submitted for prior approval by the Tohono O'odham Legislative
7 Council.


8 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 03rd
9 day of MARCH 2025 at a meeting at which a quorum was present with a vote of 3,263.3 FOR;
10 -0- AGAINST; [01] NOT VOTING; and [01] ABSENT, pursuant to the powers vested in the Council by
11 Article IX, Section 7 of the Constitution of the Tohono O'odham Nation, adopted by the Tohono
12 O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -
13 Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934
14 (48 Stat.984).




