RESOLUTION NO. 25-071

1 **WHEREAS,** the Tohono O'odham Legislative Council is vested with the power to enact laws
2 and ordinances governing the enrollment and adoption of members
3 (Constitution of the Tohono O'odham Nation, Article II, Sections 1 and 2 and
4 Article VI, Section 1(h)); and

5 **WHEREAS,** pursuant to Article VI and VII of the Nation's Enrollment Ordinance, the
6 Enrollment Committee shall review membership applications and make a
7 written recommendation to the Tohono O'odham Legislative Council to approve
8 or reject the application (14 Tohono O'odham Code Chapter 1 - Enrollment
9 Ordinance); and

10 **WHEREAS,** pursuant to Article VIII of the Nation's Enrollment Ordinance, the Tohono
11 O'odham Legislative Council shall determine eligibility for membership or
12 adoption; and

13 **WHEREAS,** the Enrollment Program has received official documents reflecting the legal
14 name changes of enrolled members as a result of marriage, divorce, legal
15 adoption, or for other reasons; and

16 **WHEREAS,** the Enrollment Committee recommends that Resolution Nos. 15-82, 40-84, 94-
17 262, 00-397, 01-543, 04-109, 05-301, 06-002, 06-511, 06-787, 07-500, 11-282, 22-210
18 and 23-098 be amended to reflect the legal name changes of members identified
19 in the April 2025 Legal Enrollment Resolution Summary, which is incorporated by
20 this reference.

21 **NOW, THEREFORE, BE IT RESOLVED** by the Tohono O'odham Legislative Council that Resolution
22 Nos. 15-82, 40-84, 94-262, 00-397, 01-543, 04-109, 05-301, 06-002, 06-511, 06-787,
23 07-500, 11-282, 22-210 and 23-098 are amended upon the effective date of those
24 resolutions to reflect the legal name changes of members identified in the April
25 2025 Legal Enrollment Resolution Summary.


26 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 07TH**
