14		membership and adoption applications misspelled or incorrectly listed the
15		names of members and/or incorrectly listed enrollment numbers; and
16	WHEREAS,	the Enrollment Committee recommends that Resolution Nos. 99-140, 04-109, 07-
17		075, 08-035, 08-330, 08-456, 08-644, 09-477 and 21-419 be amended to reflect the
18		correct name and/or enrollment number for the members identified in the April
19		2025 Corrected Enrollment Resolution Summary, which is incorporated by this
20		reference.
