


RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Amending Enrollment Resolution No. 17-003 "Approving Enrollment Applications
for Membership into the Tohono O'odham Nation for January 2017,"
to Delete Member who was Approved Twice)

RESOLUTION NO. 25-073

1 **WHEREAS,** the Tohono O'odham Legislative Council is vested with the power to enact laws
2 and ordinances governing the enrollment and adoption of members
3 (Constitution of the Tohono O'odham Nation, Article VI, Section 1(h)); and
4 **WHEREAS,** Articles VI and VII of the Nation's Enrollment Ordinance provide that the
5 Enrollment Committee is responsible for reviewing enrollment applications and
6 making recommendations to the Legislative Council regarding the eligibility of
7 applicants (Ordinance No. 05-81, as amended; 14 T.O.C. Chapter 1); and
8 **WHEREAS,** the Enrollment Program has determined that a member was originally approved
9 for membership by Resolution No. 96-260 and was mistakenly approved a second
10 time for membership by Resolution No. 17-003; and
11 **WHEREAS,** the Enrollment Committee recommends that Resolution No. 17-003 be amended
12 to delete the member identified in the attached Amending Enrollment Resolution
13 List for April 2025; and
14 **WHEREAS,** the member that was originally approved in Resolution No. 96-260 will retain the
15 roll number and approval date identified in that resolution.
16 **NOW, THEREFORE, BE IT RESOLVED** by the Tohono O'odham Legislative Council that Resolution
17 No. 17-003, "Approving Enrollment or Adoption Applications for Membership into
18 the Tohono O'odham Nation for January 2017," is amended upon the effective
19 date of that resolution to delete the member and corresponding information
20 identified in the attached Amending Enrollment Resolution List for April 2025.

21 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 07TH
22 day of APRIL 2025 at a meeting at which a quorum was present with a vote of 3,263.3 FOR; -0-
23 AGAINST; -0- NOT VOTING; and -0- ABSENT, pursuant to the powers vested in the Council by
24 Article II, Sections 1 and 2 and Article VI, Section 1(h) of the Constitution of the Tohono O'odham
25 Nation, adopted by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting
26 Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section
27 16 of the Act of June 18, 1934 (48 Stat.984).
