

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2025 Sells District North Communities Gaming Revenues Budget
Amendment No. 1)**

RESOLUTION NO. 25-089

1 **WHEREAS, pursuant to Article IX, Section 7 of the Constitution of the Tohono O'odham**
2 **Nation,**

3 **No district council shall expend district funds except pursuant to budgets**
4 **authorized under resolutions of the district council and approved by the**
5 **Tohono O'odham Council. The management of these funds shall be only by a**
6 **treasurer or other authorized officer of the district council who has**
7 **furnished a surety bond satisfactory to the treasurer of the Tohono O'odham**
8 **Nation, and all expenditures of these funds shall be by checks signed by such**
9 **treasurer or other authorized officer and the chairman or vice chairman of**
10 **the district council.**

12 **WHEREAS, the FY 2025 Sells District North Communities Gaming Revenues Budget in the**
13 **amount of \$275,000.00 was authorized by Sells District Council Resolution No. SD-**
14 **78-24 and approved by Legislative Council Resolution No. 24-323; and**

15 **WHEREAS, by Sells District Council Resolution No. SD-34-25, the Sells District has authorized**
16 **and submitted for review and approval its FY 2025 Sells District North**
17 **Communities Gaming Revenues Budget Amendment No. 1, which is incorporated**
18 **by this reference and which will adjust operational and/or personnel line items;**
19 **and**

20 **WHEREAS, the FY 2025 Sells District North Communities Gaming Revenues Budget**
21 **Amendment No. 1 will not change the FY 2025 Sells District North Communities**
22 **Gaming Revenues Budget amount of \$275,000.00; and**

23 **WHEREAS, the Budget and Finance Committee has reviewed the FY 2025 Sells District North**
24 **Communities Gaming Revenues Budget Amendment No. 1 and recommends its**
25 **approval.**

26 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**
27 **FY 2025 Sells District North Communities Gaming Revenues Budget Amendment**
28 **No. 1 effective October 1, 2024, which will not change the FY 2025 Sells District**
29 **North Communities Gaming Revenues Budget amount of \$275,000.00.**

30 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the FY 2025 Sells**
31 **District North Communities Gaming Revenues Budget as amended shall be**
32 **managed and expended in accordance with Article IX, Section 7 of the**
