The management of these funds shall be only by 6 a treasurer or other authorized officer of the district council who has 7 furnished a surety bond satisfactory to the treasurer of the Tohono 8 O'odham Nation, and all expenditures of these funds shall be hy checks 9 signed by such treasurer or other authorized officer and the chairman or 10 vice chairman of the district council. 11 ; and by Schuk Toak District Council Resolution No. ST-03-08-25-026 the Schuk Toak 12 WHEREAS, District has authorized the FY 2025-2027 Schuk Toak District RBC Wealth 13 14 Management Communities Approved Projects Investment Budgets, which are incorporated by this reference, in the amount of \$656,411.04; and 15 16 WHEREAS. the Budget and Finance Committee has reviewed the FY 2025-2027 Schuk Toak District RBC Wealth Management Communities Approved Projects Investment 17 18 Budgets and recommends their approval. 19 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the 20 FY 2025-2027 Schuk Toak District RBC Wealth Management Communities Approved Projects Investment Budgets effective October 1, 2024 in the amount of 21 \$656,411.04, which shall be funded by the RBC Wealth Management Approved 22 23 Projects Investment funds. 24 BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the FY 2025-2027 25 Schuk Toak District RBC Wealth Management Communities Approved Projects 26 Investment Budgets shall be managed and expended in accordance with Article 27 IX, Section 7 of the Constitution of the Tohono O'odham Nation and the Nation's 28 laws, provided that any amendments or modifications shall be authorized under 29 District Council resolution and submitted for prior approval by the Tohono 30 O'odham Legislative Council.
