

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2025 San Xavier Cooperative Association 9B Farm Cashout
Fund Budget Amendment)**

RESOLUTION NO. 25-094

1 **WHEREAS,** the Tohono O'odham Legislative Council is vested with the authority to "consult,
2 negotiate and conclude agreements and contracts . . . with Federal, State and
3 local governments . . ." and to "consult with the Congress of the United States and
4 appropriate federal agencies regarding federal activities that affect the Tohono
5 O'odham Nation . . ." and to "enact laws, ordinances and resolutions necessary or
6 incidental to the exercise of its legislative powers." (Constitution of the Tohono
7 O'odham Nation, Article VI, Section I(f), I(j), and 1(1)); and

8 **WHEREAS,** the FY 2025 San Xavier Cooperative Association 9B Farm Cashout Fund Budget in
9 the amount of \$1,280,000.00 was authorized by San Xavier District Council
10 Resolution No. SXDC 09-24-19 and approved by Legislative Council Resolution No.
11 24-343; and

12 **WHEREAS,** by San Xavier District Council Resolution No. SXDC 02-25-10, the San Xavier
13 District has authorized and submitted for review and approval its FY 2025 San
14 Xavier Cooperative Association 9B Farm Cashout Fund Budget Amendment,
15 which is incorporated by this reference and which will adjust operational and/or
16 personnel line items; and

17 **WHEREAS,** the FY 2025 San Xavier Cooperative Association 9B Farm Cashout Fund Budget
18 Amendment will increase the FY 2025 San Xavier Cooperative Association 9B
19 Farm Cashout Fund Budget by \$421,634.72 from \$1,280,000.00 to \$1,701,634.72;
20 and

21 **WHEREAS,** the Budget and Finance Committee has reviewed the FY 2025 San Xavier
22 Cooperative Association 9B Farm Cashout Fund Budget Amendment and
23 recommends its approval.

24 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Nation Legislative Council:

- 25 (1) approves the FY 2025 San Xavier Cooperative Association 9B Farm Cashout
26 Fund Budget Amendment which includes a \$421,634.72 increase from
27 \$1,280,000.00 to \$1,701,634.72, which shall be funded by the San Xavier
28 District 9B Farm Cashout Fund, provided that any amendments or
29 modifications shall be submitted for prior approval by the San Xavier
30 District Council and the Tohono O'odham Legislative Council; and



- (2) approves the expenditure of the SAWRSA Amendments 9B Farm Cashout Funds in accordance with the FY 2025 San Xavier Cooperative Association 9B Farm Cashout Fund Budget.

The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 10TH day of APRIL 2025 at a meeting at which a quorum was present with a vote of 3,263.3 FOR; -0- AGAINST; -0- NOT VOTING; and -0- ABSENT, pursuant to the powers vested in the Council by Article VI, Section 1(i), 1(j), and 1(1) of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat.984).






