16	WHEREAS,	the Budget and Finance Committee has reviewed the FY 2025 Chukut Kuk Distric
17		San Miguel Community Mining Royalties Budget and recommends its approval.
18	NOW, THERE	EFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the
19		FY 2025 Chukut Kuk District San Miguel Community Mining Royalties Budge
20		effective October 1, 2024 in the amount of \$8,486.78, which shall be funded as
21		follows:
22		1. FY 2020 mining royalties in the amount of \$2,535.07; and
23		2. FY 2023 mining royalties in the amount of \$5,951.71.
