16	WHEREAS,	the Human Resources Department, with the assistance of the Office of Attorney				
17		General, has prepared and submitted for review and approval the revised FY 2025				
18		Attorney Contract between the Tohono O'odham Nation and Yoder & Langford,				
19		P.C., which is incorporated by this reference, for legal services related to the				
20		Nation's 401(k) Retirement Plan for the period beginning October 1, 2024 through				
21		September 30, 2025; and				
22	WHEREAS,	the Human Resources Development and Domestic Affairs Committees have				
23		reviewed the revised Attorney Contract and recommend its approval.				
24	NOW, THERI	EFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the				
25		revised FY 2025 Attorney Contract between the Tohono O'odham Nation and
