RESOLUTION NO. 25-108

1 **WHEREAS, the Tohono O'odham Legislative Council is vested with the power to enact laws**
2 **and ordinances governing the enrollment and adoption of members**
3 **(Constitution of the Tohono O'odham Nation, Article II, Sections 1 and 2 and**
4 **Article VI, Section 1(h)); and**

5 **WHEREAS, pursuant to Articles VI and VII of the Nation's Enrollment Ordinance, the**
6 **Enrollment Committee shall review membership applications and make a**
7 **written recommendation to the Tohono O'odham Legislative Council to approve**
8 **or reject the application (14 Tohono O'odham Code Chapter 1 – Enrollment**
9 **Ordinance); and**

10 **WHEREAS, pursuant to Article VIII of the Nation's Enrollment Ordinance, the Tohono**
11 **O'odham Legislative Council shall determine eligibility for membership or**
12 **adoption; and**

13 **WHEREAS, the Enrollment Program has received official documents reflecting the legal**
14 **name changes of enrolled members as a result of marriage, divorce, legal**
15 **adoption, or for other reasons; and**

16 **WHEREAS, the Enrollment Committee recommends that Resolution Nos. 66-80, 98-83, 27-84,**
17 **292-90, 91-549, 93-183, 97-480, 98-083, 99-311, 2000-003, 04-212, 16-500, 21-416,**
18 **22-191, and 23-282 be amended to reflect the legal name changes of members**
19 **identified in the May 2025 Legal Enrollment Resolution Summary, which is**
20 **incorporated by this reference.**

21 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that Resolution**
22 **Nos. 66-80, 98-83, 27-84, 292-90, 91-549, 93-183, 97-480, 98-083, 99-311, 2000-003,**
23 **04-212, 16-500, 21-416, 22-191, and 23-282 are amended upon the effective date of**
24 **those resolutions to reflect the legal name changes of members identified in the**
25 **May 2025 Legal Enrollment Resolution Summary.**


26 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 05TH**

31 **Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section**
32 **16 of the Act of June 18, 1934 (48 Stat.984).**
