RESOLUTION NO. 25-109

1 **WHEREAS, the Tohono O'odham Legislative Council is vested with the power to enact laws**
2 **and ordinances governing the enrollment and adoption of members**
3 **(Constitution of the Tohono O'odham Nation, Article II, Sections 1 and 2 and**
4 **Article VI, Section 1(h)); and**

5 **WHEREAS, pursuant to Article VI and VII of the Nation's Enrollment Ordinance, the**
6 **Enrollment Committee shall review membership applications and make a**
7 **written recommendation to the Tohono O'odham Legislative Council to approve**
8 **or reject the application (14 Tohono O'odham Code Chapter 1 - Enrollment**
9 **Ordinance); and**

10 **WHEREAS, pursuant to Article VIII of the Nation's Enrollment Ordinance, the Tohono**
11 **O'odham Legislative Council shall determine eligibility for membership or**
12 **adoption; and**

13 **WHEREAS, the Enrollment Program has determined that a number of resolutions approving**
14 **membership and adoption applications misspelled or incorrectly listed the**
15 **names of members and/or incorrectly listed enrollment numbers; and**

16 **WHEREAS, the Enrollment Committee recommends that Resolution Nos. 94-154, 04-109, 06-**
17 **578, 07-112, 07-500, 07-657, 07-706, 08-100, 08-606, 09-101, 11-566, 25-050, and 25-**
18 **063 amended to reflect the correct name and/or enrollment number for the**
19 **members identified in the May 2025 Corrected Enrollment Resolution Summary,**
20 **which is incorporated by this reference.**

21 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that Resolution**
22 **Nos. 94-154, 04-109, 06-578, 07-112, 07-500, 07-657, 07-706, 08-100, 08-606, 09-101,**
23 **11-566, 25-050, and 25-063 are amended upon the effective date of those**
24 **resolutions to reflect the correct names and/or enrollment number of members**
25 **identified in the May 2025 Corrected Enrollment Resolution Summary.**


26 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 05TH**
