7	WHEREAS,	on June 28, 1997, the Nation's voters approved Initiative No. IN-01-97, the
8		"O'odham Voice on Use of Gaming Revenues" (the "Initiative"), which authorizes
9		per capita payments to the Nation's members provided that sufficient gaming
0		revenues are available; and
1	WHEREAS,	the Ordinance for the Regulation of Gaming Activities Within the Tohono
12		O'odbam Nation ("Gaming Ordinance") was subsequently amended to authorize
13		per capita distribution payments in accordance with the Initiative (Legislative
4		Council Resolution No. 97-303); and
5	WHEREAS,	the Trust Agreement with Principal Trust Company requires that a listing of all
6		minor beneficiaries turning 18 that month be presented to the Tohono O'odham
7		Legislative Council to obtain approval to distribute the trust funds to these
8		eligible minor members as they are no longer restricted beneficiaries; and
9	WHEREAS,	by Resolution Nos. 24-413 and 25-031 the Tohono O'odham Legislative Council
20		approved the Monthly Age 18 Reports for December 2024 and February 2025 of
21		eligible minor members who reached the age of 18 and are no longer restricted
22		from receiving their per capita payments; and
23	WHEREAS,	the Nation's Enrollment Office has identified incorrect names and or dates of
24		births for members on the Monthly Age 18 Reports for December 2024 and
25		February 2025 and recommends that the names and or dates of births of the
26		members be corrected on the Monthly Age 18 Reports for December 2024 and
27		February 2025; and
28	WHEREAS,	the Nation's Enrollment Office recommends that the names and or dates of births
29		of the members be amended on the Monthly Age 18 Reports for December 2024
30		and February 2025.
31	WHEREAS,	the Rules Committee has reviewed the Enrollment Office's recommendations
32		and Recommends approval.
