The management of these funds shall be only by a treasurer or other authorized officer of the district council who has 6 7 furnished a surety bond satisfactory to the treasurer of the Tohono O'odham 8 Nation, and all expenditures of these funds shall be by checks signed by such 9 treasurer or other authorized officer and the chairman or vice chairman of 10 the district council. 11 ; and 12 WHEREAS. the FY 2025 Baboquivari District Cold Fields Community Budget in the amount of 13 \$548,404.54 was authorized by Baboquivari District Council Resolution No. 2024-14 B-85 and approved by Legislative Council Resolution No. 24-325; and 15 WHEREAS. by Baboquivari District Council Resolution No. 2025-B-34, the Baboquivari 16 District has authorized and submitted for review and approval its FY 2025 17 Baboquivari District Cold Fields Community Budget Amendment No. 1, which is 18 incorporated by this reference and which will adjust operational and/or 19 personnel line items; and 20 WHEREAS, the FY 2025 Baboquivari District Cold Fields Community Budget Amendment No. 21 1 will not change the FY 2025 Baboquivari District Cold Fields Community Bndget 22 amount of \$548,404.54; and 23 the Budget and Finance Committee has reviewed the FY 2025 Baboquivari District WHEREAS, 24 Cold Fields Community Budget Amendment No. 1 and recommends its approval. 25 NOW, THEREFORE, BE IT RESOLVED that the Tobono O'odham Legislative Council approves the 26 FY 2025 Baboquivari District Cold Fields Community Budget Amendment No. 1 27 effective October 1, 2024, which will not change the FY 2025 Baboquivari District 28 Cold Fields Community Budget amount of \$548,404.54. 29 BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the FY 2025 30 Baboquivari District Cold Fields Community Budget as amended shall be
