

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Approving FY 2025 Baboquivari District Cold Fields Community Budget Amendment No. 1)**

**RESOLUTION NO. 25-115**

1 **WHEREAS,** pursuant to Article IX, Section 7 of the Constitution of the Tohono O'odham  
2 Nation,

3 No district council shall expend district funds except pursuant to budgets  
4 authorized under resolutions of the district council and approved by the  
5 Tohono O'odham Council. The management of these funds shall be only by  
6 a treasurer or other authorized officer of the district council who has  
7 furnished a surety bond satisfactory to the treasurer of the Tohono O'odham  
8 Nation, and all expenditures of these funds shall be by checks signed by such  
9 treasurer or other authorized officer and the chairman or vice chairman of  
10 the district council.

12 **WHEREAS,** the FY 2025 Baboquivari District Cold Fields Community Budget in the amount of  
13 \$548,404.54 was authorized by Baboquivari District Council Resolution No. 2024-  
14 B-85 and approved by Legislative Council Resolution No. 24-325; and

15 **WHEREAS,** by Baboquivari District Council Resolution No. 2025-B-34, the Baboquivari  
16 District has authorized and submitted for review and approval its FY 2025  
17 Baboquivari District Cold Fields Community Budget Amendment No. 1, which is  
18 incorporated by this reference and which will adjust operational and/or  
19 personnel line items; and

20 **WHEREAS,** the FY 2025 Baboquivari District Cold Fields Community Budget Amendment No.  
21 1 will not change the FY 2025 Baboquivari District Cold Fields Community Budget  
22 amount of \$548,404.54; and

23 **WHEREAS,** the Budget and Finance Committee has reviewed the FY 2025 Baboquivari District  
24 Cold Fields Community Budget Amendment No. 1 and recommends its approval.

25 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council approves the  
26 FY 2025 Baboquivari District Cold Fields Community Budget Amendment No. 1  
27 effective October 1, 2024, which will not change the FY 2025 Baboquivari District  
28 Cold Fields Community Budget amount of \$548,404.54.

29 **BE IT FINALLY RESOLVED** by the Tohono O'odham Legislative Council that the FY 2025  
30 Baboquivari District Cold Fields Community Budget as amended shall be  
31 managed and expended in accordance with Article IX, Section 7 of the  
32 Constitution of the Tohono O'odham Nation and the Nation's laws, provided that  
33 any amendments or modifications shall be authorized under District Council
