3		committees, boards and special committees." (Constitution of the Tohono
4		O'odham Nation, Article VI, Section 1(a)); and
5	WHEREAS,	the Legislative Rules of the Tohono O'odham Legislative Council vests the Council
6		with the authority to "by majority vote, call for a special session" (Legislative
7		Rules of the Tohono O'odham Legislative Council, Article I, Section 1.D.1.); and
8	WHEREAS,	Article I, Section 2(C) of the Legislative Rules of the Tohono O'odham Legislative
9	WILLIAM,	Council, provides that "[a]ll Legislative Council sessions shall be held at the
10		Tohono O'odham Legislative Council chambers located in Sells, Tohono O'odham
11		Nation, with the following exceptions [a] majority of all the legislative
12		representatives may vote to hold a session in some location other than the
13		chambers located at Sells."; and
14	WHEREAS,	the Commerce Committee has requested a special session on May 14, 2025 for
15		Tohono O'odham Gaming Enterprise's annual report.

17		special session on May 14, 2025 with roll call beginning at 10:00 a.m. for Tohono
