

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2025 Legislative Branch Budget Amendment No. 2)**

RESOLUTION NO. 25-129

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**
2 **within the exclusive control of the Tohono O'odham Nation . . . and to appropriate**
3 **these funds for the benefit of the nation and its members" provided that "[a]ll**
4 **expenditures of these funds shall be pursuant to appropriations or budgets"**
5 **authorized by resolution or ordinance (Constitution of the Tohono O'odham**
6 **Nation, Article VI, Section 1(d)(2)); and**

7 **WHEREAS, the FY 2025 Legislative Branch Budget in the amount of \$6,286,584.32 was**
8 **approved by Resolution No. 24-314 and subsequently amended by Resolution No.**
9 **24-396; and**

10 **WHEREAS, the Legislative Branch has prepared and submitted for review and approval its FY**
11 **2025 Legislative Branch Budget Amendment No. 2, which is incorporated by this**
12 **reference and which will adjust operational and/or personnel line items; and**

13 **WHEREAS, the FY 2025 Legislative Branch Budget Amendment No. 2 will not change the FY**
14 **2025 Legislative Branch Budget amount of \$6,286,584.32; and**

15 **WHEREAS, the Budget and Finance Committee has reviewed the FY 2025 Legislative Branch**
16 **Budget Amendment No. 2 and recommends its approval.**

17 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**
18 **FY 2025 Legislative Branch Budget Amendment No. 2 effective October 1, 2024,**
19 **which will not change the FY 2025 Legislative Branch Budget amount of**
20 **\$6,286,584.32.**


21 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**
22 **Legislative Council chairperson or any designated official is authorized to**
23 **administer and expend the FY 2025 Legislative Branch Budget as amended,**
24 **provided that any modifications shall be submitted to the Budget and Finance**
25 **Committee for approval on behalf of the Legislative Council and amendments**
26 **shall be submitted for prior approval by the Tohono O'odham Legislative Council.**

27 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 06TH**
28 **day of MAY, 2025 at a meeting at which a quorum was present with a vote of 3,263.3 FOR; -0-**
29 **AGAINST; -0- NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by**
30 **Article VI, Section 1(d)(2)and(3) of the Constitution of the Tohono O'odham Nation, adopted by**
31 **the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
32 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
33 **18, 1934 (48 Stat.984).**
