

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Approving FY 2025 Credit & Finance Program B.I.A PL 93-638 Budget Amendment No. 1)**

**RESOLUTION NO. 25-134**

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**  
2 **within the exclusive control of the Tohono O'odham Nation . . . and to appropriate**  
3 **these funds for the benefit of the nation and its members" provided that "[a]ll**  
4 **expenditures of these funds shall be pursuant to appropriations or budgets"**  
5 **authorized by resolution or ordinance (Constitution of the Tohono O'odham**  
6 **Nation, Article VI, Section 1(d)(2)); and**

7 **WHEREAS, the FY 2025 Credit & Finance Program B.I.A. PL 93-638 Budget in the amount of**  
8 **\$442,735.00 was approved by Resolution No.24-281; and**

9 **WHEREAS, the Credit & Finance Program has prepared and submitted for review and**  
10 **approval its FY 2025 B.I.A. PL 93-638 Budget Amendment No. 1, which is**  
11 **incorporated by this reference and which will adjust the following line items:**  
12 **6500 Training Fees and Registration, 6510 Lodging, 6520 Per Diem, 6530**  
13 **Transportation, 7010 Program Supplies, 7100 Utilities, 7110 Communication**  
14 **Expenses, 7340 Public Relations and 7355 Professional Services; and**

15 **WHEREAS, the FY 2025 Credit & Finance Program Amendment No. 1 will increase the FY 2025**  
16 **Credit & Finance Program B.I.A. PL 93-638 Budget from \$442,735.00 to**  
17 **\$531,501.95, for a total increase of \$88,766.95; and**

18 **WHEREAS, the Commerce and Budget and Finance Committees have reviewed the FY 2025**  
19 **Credit & Finance Program B.I.A. PL 93-638 Budget Amendment No. 1 and**  
20 **recommend its approval.**

21 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**  
22 **FY 2025 Credit & Finance Program B.I.A. PL 93-638 Budget Amendment No. 1**  
23 **effective October 1, 2024, which increases the budget from \$442,735.00 to**  
24 **\$531,501.95, for a total increase of \$88,766.95 that shall be funded by the B.I.A. PL**  
25 **93-638 savings.**

26 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**  
27 **Nation chairperson or any designed official is authorized to administer and**  
28 **expend the FY 2025 Credit & Finance Program B.I.A. PL 93-638 Budget as**  
29 **amended, provided that any amendments or modifications shall be submitted**  
30 **for prior approval by the Tohono O'odham Legislative Council.**




