

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Approving the Planning and Economic Development Department Roads Program Contract for**  
**Road Maintenance Services between Tohono O'odham Nation and Spencer Construction, LLC)**

**RESOLUTION NO. 25-136**

1 **WHEREAS, the Constitution of the Tohono O'odham Nation vests the Legislative Council with**  
2 **the power "[t]o conslt, negotiate and conclude agreements and contracts on**  
3 **behalf of the Tohono O'odham Nation with Federal, State and local governments**  
4 **and other Indian tribes or their departments, agencies, or political subdivisions,**  
5 **or with private persons or organizations on all matters within the authority of the**  
6 **Tohono O'odham Council" (Constitution of the Tohono O'odham Nation, Article**  
7 **VI, Section l(f)); and**

8 **WHEREAS, the Planning and Economic Development Department Roads Program provides**  
9 **project management and contracting in architectural design, general**  
10 **construction contracting, infrastructure development and long-range facilities**  
11 **planning for the Tohono O'odham Nation; and**

12 **WHEREAS, the Planning and Economic Development Department has submitted for**  
13 **approval a contract for road maintenance services between the Tohono O'odham**  
14 **Nation and Spencer Construction, LLC, which is incorporated by this reference,**  
15 **for the Roads Program Project PIR Road Maintenance within the Tohono**  
16 **O'odham Nation; and**

17 **WHEREAS, the total cost of the proposed services is \$4,224,828.69; and**

18 **WHEREAS, funds are available in the FY 2023 Planning and Economic Development**  
19 **Department Roads Program Project PIR Road Maintenance Budget, pursuant to**  
20 **Resolution No. 25-044, to fund the road maintenance services contract; and**

21 **WHEREAS, the Agricultural and Natural Resources Committee has reviewed the road**  
22 **maintenance services contract and recommends approval.**

23 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**  
24 **contract, in substantially the form attached, for road maintenance services**  
25 **between the Tohono O'odham Nation and Spencer Construction, LLC for the total**  
26 **cost of \$4,224,828.69, effective from the date of signature to September 30, 2026.**

27 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council authorizes the Nation's**  
28 **chairperson or any designated official to execute the contract for engineering**  
29 **and construction administration services, provided that any amendments or**  
30 **modifications shall be submitted for prior approval by the Tohono O'odham**  
31 **Legislative Council.**






