8		these funds for the benefit of the nation and its members" provided that "[a]ll
9		expenditures of these funds shall be pursuant to appropriations or budgets"
10		authorized by resolution or ordinance (Constitution, Article VI, Section l(d)(2));

12	WHEREAS,	the Tohono O'odham Nation Planning and Economic Development Department
13		Roads Program has prepared and submits for approval a road maintenance
14		contract with Spencer Construction for the maintenance and repair of Road
15		Maintenance Project No. 1 roads, which shall be funded by the Nation's general
16		fund pending reimbursement from the granting agency, the Bureau of Indian
17		Affairs; and
18	WHEREAS,	the contract is for a flat fee price of \$4,688,971.96; and
19	WHEREAS,	the Agricultural and Natural Resources Committee has reviewed the contract
20		documents in substantially the form attached and recommends approval.
21	NOW, THERE	FORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the
22		road maintenance and construction contract, in substantially the form attached,
23		between the Tohono O'odham Nation and Spencer Construction for the
24		maintenance and repair of the Road Maintenance Project No. 1 roads.
25	BE IT FINALI	LY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham
26		Nation chairperson or any designated official is authorized to execute and
27		administer the road maintenance and construction contract, provided that any
28		amendments or modifications must be submitted to the Tohono O'odham
29		Legislative Council for prior approval.
