

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2025 Sells District Kawulk Community Budget Amendment No. 1)

RESOLUTION NO. 25-139

1 **WHEREAS,** pursuant to Article IX, Section 7 of the Constitution of the Tohono O'odham
2 Nation,

3 No district council shall expend district funds except pursuant to budgets
4 authorized under resolutions of the district council and approved by the
5 Tohono O'odham Council. The management of these funds shall be only by
6 a treasurer or other authorized officer of the district council who has
7 furnished a surety bond satisfactory to the treasurer of the Tohono O'odham
8 Nation, and all expenditures of these funds shall be by checks signed by such
9 treasurer or other authorized officer and the chairman or vice chairman of
10 the district council.

12 **WHEREAS,** the FY 2025 Sells District Administration and Community Budgets in the amount
13 of \$4,735,610.33 was authorized by Sells District Council Resolution SD-78-24 and
14 approved by Legislative Council Resolution No. 24-323; and

15 **WHEREAS,** by Sells District Council Resolution No. SD-63-25, the Sells District has authorized
16 and submitted for review and approval its FY 2025 Sells District Kawulk
17 Community Budget Amendment No. 1, which is incorporated by this reference
18 and which will adjust operational and/or personnel line items; and

19 **WHEREAS,** the FY 2025 Sells District Kawulk Community Budget Amendment No. 1 will not
20 change the FY 2025 Sells District Kawulk Community Budget amount of
21 \$275,000.00; and

22 **WHEREAS,** the Budget and Finance Committee has reviewed the FY 2025 Sells District Kawulk
23 Community Budget Amendment No. 1 and recommends approval.

24 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council approves the
25 FY 2025 Sells District Kawulk Community Budget Amendment No. 1 effective
26 October 1, 2024, which will not change the FY 2025 Sells District Kawulk
27 Community Budget amount of \$275,000.00 nor will it change the FY 2025 Sells
28 District Administration and Community Budgets amount of \$4,735,610.33.

29 **BE IT FINALLY RESOLVED** by the Tohono O'odham Legislative Council that the FY 2025 Sells
30 District Kawulk Community Budget as amended shall be managed and expended
31 in accordance with Article IX, Section 7 of the Constitution of the Tohono
32 O'odham Nation and the Nation's laws, provided that any amendments or



modifications shall be authorized under District Council resolution and submitted for prior approval by the Tohono O'odham Legislative Council.

The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 07TH day of MAY, 2025 at a meeting at which a quorum was present with a vote of 3,263.3 FOR; -0- AGAINST; -0- NOT VOTING; and -0- ABSENT, pursuant to the powers vested in the Council by Article IX, Section 7 of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat.984).




