

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approving FY 2025 Sells District Administration Budget Amendment No. 1)**

**RESOLUTION NO. 25-140**

1 **WHEREAS,** pursuant to Article IX, Section 7 of the Constitution of the Tohono O'odham  
2 Nation,

3 No district council shall expend district funds except pursuant to budgets  
4 authorized under resolutions of the district council and approved by the  
5 Tohono O'odham Council. The management of these funds shall be only by  
6 a treasurer or other authorized officer of the district council who has  
7 furnished a surety bond satisfactory to the treasurer of the Tohono  
8 O'odham Nation, and all expenditures of these funds shall be by checks  
9 signed by such treasurer or other authorized officer and the chairman or  
10 vice chairman of the district council.

12 **WHEREAS,** the FY 2025 Sells District Administration and Community Budgets in the amount  
13 of \$4,735,610.33 was authorized by Sells District Council Resolution SD-78-24 and  
14 approved by Legislative Council Resolution No. 24-323; and

15 **WHEREAS,** by Sells District Council Resolution No. SD-62-25, the Sells District has authorized  
16 and submitted for review and approval its FY 2025 Sells District Administration  
17 Budget Amendment No. 1, which is incorporated by this reference and which will  
18 adjust operational and/or personnel line items; and

19 **WHEREAS,** the FY 2025 Sells District Administration Budget Amendment No. 1 will not change  
20 the FY 2025 Sells District Administration Budget amount of \$3,635,610.33; and

21 **WHEREAS,** the Budget and Finance Committee has reviewed the FY 2025 Sells District  
22 Administration Budget Amendment No. 1 and recommends approval.

23 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council approves the  
24 FY 2025 Sells District Administration Budget Amendment No. 1, effective October  
25 1, 2024, which will not change the FY 2025 Sells District Administration Budget  
26 amount of \$3,635,610.33 nor will it change the FY 2025 Sells District  
27 Administration and Community Budgets amount of \$4,735,610.33.

28 **BE IT FINALLY RESOLVED** by the Tohono O'odham Legislative Council that the FY 2025 Sells  
29 District Administration Budget as amended shall be managed and expended in  
30 accordance with Article IX, Section 7 of the Constitution of the Tohono O'odham  
31 Nation and the Nation's laws, provided that any amendments or modifications  
32 shall be authorized under District Council resolution and submitted for prior  
33 approval by the Tohono O'odham Legislative Council.




