## RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL

(Approving Low Income Home Energy Assistance Program Intergovernmental Agreement Amendment No. 9 between the Tohono O'odham Nation and the Arizona Department of Economic Security)

## **RESOLUTION NO. 25-145**

1	WHEREAS,	the Tohono O'odham Legislative Council is vested with the power "[t]o consult,
2		negotiate and conclude agreements on behalf of the Tohono O'odham Nation
3		with Federal, State and local governments or their departments, agencies,
4		or political subdivisions on all matters within the authority of the Tohono
5		O'odham Council" and "[t]o exercise the inherent powers of the Tohono O'odham
6		Nation by providing resolutions" "to promote, protect and provide for public
7		health, peace, morals, education and general welfare of the Tohono O'odham
8		Nation and its members"; and "to manage any funds within the exclusive control
9		of the Tohono O'odham Nation and to appropriate these funds for the benefit
10		of the nation and its members" provided that "[a]ll expenditures of these funds
11		shall be pursuant to appropriations or budgets" authorized by resolution or
12		ordinance (Constitution of the Tohono O'odham Nation, Article VI, Section 1(c)(2),
13		(d)(2) and (f)); and
14	WHEREAS,	the Low-Income Home Energy Assistance Program ("LIHEAP") is a federally
15		funded program, administered by the Arizona Department of Economic Security
16		("ADES"), that helps low-income bouseholds pay their heating/cooling bills,
17		minimize crises, and make energy costs more affordable; and
18	WHEREAS,	the Tohono O'odham Legislative Council previously approved the LIHEAP
19		Intergovernmental Agreement ("IGA") between the Tohono O'odham Nation
20		("Nation") and the ADES by Resolution No. 20-234 for the period of July 1, 2020
21		through June 30, 2025 which provides funding to the Nation for the LIHEAP on an
22		annual basis; and
23	WHEREAS,	the Tohono O'odham Legislative Council previously approved the LIHEAP IGA
24		Amendments Nos. 1 – 8 between the Nation and the ADES by Resolutions Nos. 21-
25		351, 22-021, 22-362, 23-202, 23-356, 24-186, and 25-144; and
26	WHEREAS,	the ADES bas submitted LIHEAP IGA Amendment No. 9, which will revise the
27		Itemized Service Budget for period of July 1, 2024, through June 30, 2025; and
28	WHEREAS,	in accordance with the Alert issued on October 24, 2024, the revised allocations
29		are as follows: The total value of the budget is revised from \$125,000.00 to
30		\$207,246.25 as detailed in the attached itemized service budget; and
