

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving Planning and Economic Development Department Roads Program
PIR 101 (2) Artesia Wash Bridge Budget Amendment No. 4 to Extend Budget Period)

RESOLUTION NO. 25-151

1 **WHEREAS,** the Tohono O'odham Legislative Council is authorized "to manage any funds
2 within the exclusive control of the Tohono O'odham Nation . . . and to appropriate
3 these funds for the benefits of the nation and its members" provided that "[a]ll
4 expenditures of these funds shall be pursuant to appropriations or budgets"
5 authorized by resolution or ordinance (Constitution of the Tohono O'odham
6 Nation, Article VI, Section 1(d)(2)); and

7 **WHEREAS,** the FY 2022 Planning and Economic Development Department Roads Program
8 PIR 101 (2) Artesia Wash Bridge Budget in the amount of \$2,589,287.60 was
9 approved by Resolution No. 21-331 and subsequently amended by Resolution Nos.
10 22-424, 23-275, and 24-138; and

11 **WHEREAS,** the Planning and Economic Development Department Roads Program has
12 received a no cost extension notice from the Bureau of Indian Affairs to extend
13 the PIR 101 (2) Artesia Wash Budget period of performance through September
14 30, 2027; and

15 **WHEREAS,** the Planning and Economic Development Department Roads Program has
16 prepared and submitted for review and approval its Planning and Economic
17 Development Roads Program PIR 101 (2) Artesia Wash Bridge Budget Amendment
18 No. 4 which is incorporated by this reference, and which will extend hudget
19 period; and

20 **WHEREAS,** the Agricultural and Natural Resources and Budget and Finance Committees
21 have reviewed the Planning and Economic Development Department Roads
22 Program PIR 101 (2) Artesia Wash Bridge Budget Amendment No. 4 and
23 recommends its approval.

24 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council approves the
25 Planning and Economic Development Department Roads Program PIR 101 (2)
26 Artesia Wash Bridge Amendment No. 4 which will extend the hudget period
27 effective October 1, 2025 through September 30, 2027.

28 **BE IT FINALLY RESOLVED** by the Tohono O'odham Legislative Council that the Tohono O'odham
29 Nation chairperson or any designated official is authorized to administer and
30 expend the Planning and Economic Development Department Roads Program
31 PIR 101 (2) Artesia Wash Bridge Budget as amended, provided that any



amendments or modifications shall be submitted for prior approval by the
Tohono O'odham Legislative Council.

The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 14TH day of MAY, 2025 at a meeting at which a quorum was present with a vote of 3,263.3 FOR; -0- AGAINST; -0- NOT VOTING; and [04] ABSENT, pursuant to the powers vested in the Council by Article VI, Section 1(d)(2) of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat.984).




