2		the power to "negotiate and conclude agreements and contracts on behalf of the
3	ļ	Tohono O'odham Nation with private persons or organizations on all matters
4		within the authority of the Tohono O'odham Council" (Constitution, Article VI,
5		Section 1(f)); and
6	WHEREAS,	26 T.O.C. Article 4, Section 1405 vests the Legislative Council chairperson with the
7		authority to negotiate, execute, and conclude contracts that expend funds
8		pursuant to appropriations or budgets authorized by resolution, that are within
9		the authorities delegated to the Council chairperson and vice chairperson by the
10		Legislative Council, and in amounts not to exceed \$100,000; and
11	WHEREAS,	the Legislative Council by Resolution No. 22-311 approved the FY 2022-FY 2025
12		Legislative Branch American Rescue Plan Act Budget, which includes funding to
13		cover costs associated with the construction of the Legislative Branch
14		replacement building, and which was subsequently amended by Resolution No.
15		24-362 as the FY 2025-FY 2027 Legislative Branch American Rescue Plan Act
16		Budget; and
17	WHEREAS,	the Legislative Council chairperson has selected Rytan LLC to replace Axios
18		Builders LLC for the construction of the Legislative Branch replacement building;
19		and
20	WHEREAS,	the AIA A101-2017 Standard Form of Agreement Between Owner and Contractor
21		and AIA A201-2017 General Conditions of the Contract for Construction between
22		the Tohono O'odham Legislative Branch and Rytan LLC for the replacement
23		building (collectively, the "Agreement"), which is incorporated by this reference,
24		is for an amount not to exceed \$29,405,119.18 and contains certain terms and
25		conditions that require a limited waiver of the Legislative Branch's sovereign
26		immunity pursuant to §13.1.2 of the Agreement; and
27	WHEREAS,	the Legislative Council officers have reviewed the Agreement, including the
28		limited waiver of the Legislative Branch's sovereign immunity, and recommend
29		its approval.
30	NOW, THERE	FORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the
31		Agreement between the Tohono O'odham Legislative Branch and Rytan LLC in

1	substantially the form presented to the Legislative Council and in an amount no
2	to exceed \$29,405,119.18.
3	BE IT FURTHER RESOLVED by the Tohono O'odham Legislative Council that the Agreement shal
4	be funded by the FY 2022-FY 2025 Legislative Branch American Rescue Plan Ac
5	Budget, the FY 2025-FY 2027 Legislative Branch American Rescue Plan Act Budget
6	and the FY 2025-2027 Legislative Branch Legislative Replacement Building
7	Supplemental Budget.
8	BE IT FURTHER RESOLVED that the Tohono O'odham Legislative Council approves a limited
9	waiver of the Legislative Branch's sovereign immunity consistent with the
10	Agreement's terms.
11	BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council authorizes the
12	Legislative Council chairperson to execute the Agreement between the Tohono
13	O'odham Legislative Branch and Rytan LLC.
