


LEGISLATIVE ORDER OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Certifying Election of Marlakay Henry as Vice Chairperson of the
Tohono O'odham Legislative Council)

LEGISLATIVE ORDER NO. 25-161

1 **WHEREAS, the Legislative Council is vested with the power to "elect from among its own**
2 **membership a chairman and vice-chairman" (Constitution of the Tohono**
3 **O'odham Nation, Article V, Section 4); and**
4 **WHEREAS, during the June 2025 general session, the Legislative Council conducted an**
5 **election for the office of the Legislative Council vice chairperson in accordance**
6 **with Article XII, Section 2 of the Legislative Rules of the Tohono O'odham**
7 **Legislative Council; and**
8 **WHEREAS, each Council representative had the opportunity to vote for one of the candidates**
9 **nominated for the office of Legislative Council vice chairperson; and**
10 **WHEREAS, Representative Marlakay Henry, having received a majority of the votes cast, was**
11 **declared the Legislative Council vice chairperson-elect.**
12 **NOW, THEREFORE, BE IT ORDERED that the Tohono O'odham Legislative Council certifies the**
13 **election of Marlakay Henry as vice chairperson of the Tohono O'odham**
14 **Legislative Council.**

15 **The foregoing Order was passed by the Tohono O'odham Legislative Council on the 12th day of**
16 **JUNE, 2025 at a meeting at which a quorum was present with a vote of 3,321.1 FOR; -0- AGAINST;**
17 **-0- NOT VOTING; and -0- ABSENT, pursuant to the powers vested in the Council by Article V,**
18 **Section 4 of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham**
19 **Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian**
20 **Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**
21 **Stat.984).**
