## RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL (Approving FY 2025 Baboquivari District American Rescue Plan Act Budget Amendment No. 1)

RESOLUTION NO. 25-166

1 WHEREAS. pursuant to Article IX, Section 7 of the Constitution of the Tohono O'odham 2 Nation, 3 No district council shall expend district funds except pursuant to budgets 4 authorized under resolutions of the district council and approved by the 5 Tohono O'odham Council. The management of these funds shall be only by 6 a treasurer or other authorized officer of the district council who has 7 furnished a surety bond satisfactory to the treasurer of the Tohono 8 O'odham Nation, and all expenditures of these funds shall be by checks 9 signed by such treasurer or other authorized officer and the chairman or 10 vice chairman of the district council. 11 ; and 12 WHEREAS. the FY 2021-2024 Bahoquivari District American Rescue Plan Act Budget in the 13 amount of \$4.986,181.00 was authorized by Baboquivari District Council 14 Resolution No. 2022-B-95 and approved by Legislative Council Resolution No. 23-15 126; and 16 WHEREAS. by Baboquivari District Council Resolution No. 2025-B-39, the Baboquivari 17 District has authorized and submitted for review and approval its FY 2025 18 Baboquivari District American Rescue Plan Act Budget Amendment No. 1 which 19 is incorporated by this reference, and which will adjust operational and/or line 20 items and extend the budget period; and 21 WHEREAS. the FY 2025 Baboquivari District American Rescue Plan Act Budget Amendment 22 No. 1 will not change the original budget amount of \$4,986,181.00 but will extend 23 the budget period ending on December 31, 2024 to December 31, 2026; and 24 WHEREAS. the Budget and Finance Committee has reviewed the FY 2025 Baboquivari District 25 American Rescue Plan Act Budget Amendment No. 1 and recommends its 26 approval. 27 NOW, THEREFORE BE IT RESOLVED that the Tohono O'odham Legislative Council approves the 28 FY 2025 Baboquivari District Administration American Rescue Plan Act Budget 29 Amendment No. 1 in the amount of \$4,986,181.00, effective March 11, 2021 and 30 ending December 31, 2026. 31

The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 13<sup>TH</sup> day of JUNE, 2025 at a meeting at which a quorum was present with a vote of 3,321.1 FOR; -0-AGAINST: -0- NOT VOTING; and [01] ABSENT, pursuant to the powers vested in the Council by Article IX, Section 7 of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
