

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Amending Enrollment Resolution Nos. 97-256, 07-075, 08-606, 09-369, 10-070,
10-401 and 11-402 to Correct Names of Enrolled Members)

RESOLUTION NO. 25-172

1 **WHEREAS, the Tohono O'odham Legislative Council is vested with the power to enact laws**
2 **and ordinances governing the enrollment and adoption of members**
3 **(Constitution of the Tohono O'odham Nation, Article II, Sections 1 and 2 and**
4 **Article VI, Section 1(h)); and**

5 **WHEREAS, pursuant to Article VI and VII of the Nation's Enrollment Ordinance, the**
6 **Enrollment Committee shall review membership applications and make a**
7 **written recommendation to the Tohono O'odham Legislative Council to approve**
8 **or reject the applications (14 Tohono O'odham Code Chapter 1 - Enrollment**
9 **Ordinance); and**

10 **WHEREAS, pursuant to Article VIII of the Nation's Enrollment Ordinance, the Tohono**
11 **O'odham Legislative Council shall determine eligibility for membership or**
12 **adoption; and**

13 **WHEREAS, the Enrollment Program has determined that a number of resolutions approving**
14 **membership and adoption applications misspelled or incorrectly listed the**
15 **names of members and/or incorrectly listed enrollment numbers; and**

16 **WHEREAS, the Enrollment Committee recommends that Resolution Nos. 97-256, 07-075, 08-**
17 **606, 09-369, 10-070, 10-401 and 11-402 be amended to reflect the correct name for**
18 **the members identified in the June 2025 Corrected Enrollment Resolution**
19 **Summary, which is incorporated by this reference.**

20 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that Resolution**
21 **Nos. 97-256, 07-075, 08-606, 09-369, 10-070, 10-401 and 11-402 are amended upon**
22 **the effective date of those resolutions to reflect the correct names of members**
23 **identified in the June 2025 Corrected Enrollment Resolution Summary.**


24 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 16TH**

29 **Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section**
30 **16 of the Act of June 18, 1934 (48 Stat.984).**






