7	WHEREAS,	the Department of Health and Human Services has prepared and submitted for
8		review and approval its FY 2025 Division of Behavioral Health Tribal Opioid
9		Response Grant Budget, which is incorporated by this reference, in the amount of
10		\$502,577.00 to be funded from the Nation's general fund pending reimbursement
11		by the grantor, the United States Department of Health and Human Services
12		Substance Abuse and Mental Health Services Administration; and
13	WHEREAS,	the Health and Human Services and Budget and Finance Committees have
14		reviewed the FY 2025 Department of Health and Human Services Division of
15		Behavioral Health Tribal Opioid Response Grant Budget and recommend its
16		approval.
17	NOW, THER	EFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the
18		FY 2025 Department of Health and Human Services Division of Behavioral Health
19		Tribal Opioid Response Grant Budget effective September 30, 2024 through
20		September 29, 2025 in the amount of \$502,577.00, which shall be funded by the
21		Nation's general fund pending reimbursement from the grantor, the United
22		States Department of Health and Human Services Substance Abuse and Mental
23		Health Services Administration.
24	BE IT FINAL	LY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham
25		Nation chairperson or any designated official is authorized to administer and
26		expend the FY 2025 Department of Health and Human Services Division of
27		Behavioral Health Tribal Opioid Response Grant Budget, provided that any
28		amendments or modifications shall be submitted for prior approval by the
29		Tohono O'odham Legislative Council.
