

LEGISLATIVE ORDER OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Adopting 2025-2027 Legislative Council Committee Meeting Schedule)

LEGISLATIVE ORDER NO. 25-180

1 **WHEREAS,** the Tohono O'odham Legislative Council is vested with the power to "establish
2 rules and procedures to regulate all meetings of the . . . standing committees"
3 (Constitution, Article VI, Section 1(a)); and
4 **WHEREAS,** "[t]he legislative committees of the Legislative Council are the standing
5 committees of the Legislative Branch performing continuing functions for an
6 indefinite time, whose membership shall consist of representatives to the
7 Legislative Council" (Legislative Rules of the Tohono O'odham Legislative
8 Council, Article XI, Section 1(A)(1)); and
9 **WHEREAS,** on June 12, 2025, following the election of the Chairperson and Vice Chairperson
10 of the Legislative Council, the Legislative Council elected committee members
11 and officers to the Legislative Council's 12 standing committees; and
12 **WHEREAS,** the Rules Committee has drafted a schedule listing regular Legislative Council
13 committee meetings for 2025-2027, which is dated for reference June 16, 2025.
14 **NOW, THEREFORE, BE IT ORDERED** by the Tohono O'odham Legislative Council that it adopts
15 the "2025-2027 Legislative Council Committee Meeting Schedule," which shall
16 remain in effect until committee memberships are elected following the Tohono
17 O'odham Nation's 2027 general election.


18 The foregoing Order was passed by the Tohono O'odham Legislative Council on the 16TH day of
19 JUNE, 2025 at a meeting at which a quorum was present with a vote of 2,064.25 FOR;
20 1,256.85 AGAINST; -0- NOT VOTING; and -0- ABSENT, pursuant to the powers vested in the Council
21 by Article VI, Section 1(a) of the Constitution of the Tohono O'odham Nation, adopted by the
22 Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant
23 Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June
24 18, 1934 (48 Stat.984).
