

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approving FY 2025 Sif-Oidak District Gaming Revenue Administration and  
Facility Maintenance Five Month Budget Amendment No. 1)**

**RESOLUTION NO. 25-183**

1 **WHEREAS,** pursuant to Article IX, Section 7 of the Constitution of the Tohono O'odham  
2 Nation,

3 No district council shall expend district funds except pursuant to budgets  
4 authorized under resolutions of the district council and approved by the  
5 Tohono O'odham Council. The management of these funds shall be only by  
6 a treasurer or other authorized officer of the district council who has  
7 furnished a surety bond satisfactory to the treasurer of the Tohono  
8 O'odham Nation, and all expenditures of these funds shall be by checks  
9 signed by such treasurer or other authorized officer and the chairman or  
10 vice chairman of the district council.

12 **WHEREAS,** the FY 2025 Sif-Oidak District Gaming Revenue Five Month Budget in the amount  
13 of \$1,425,926.76 was authorized by Sif-Oidak District Council Resolution No.  
14 SODC 25-068 and approved by Legislative Council Resolution No. 25-114; and

15 **WHEREAS,** by Sif-Oidak District Council Resolution No. SODC 25-071, the Sif-Oidak District  
16 has authorized and submitted for review and approval its FY 2025 Sif Oidak  
17 District Gaming Revenue Administration and Facility Maintenance Five Month  
18 Budget Amendment No. 1, which is incorporated by this reference, and which will  
19 adjust operational and/or personnel line items; and

20 **WHEREAS,** the FY 2025 Sif-Oidak District Gaming Revenue Administration and Facility  
21 Maintenance Five Month Budget Amendment No. 1 will not change the FY 2025 Sif  
22 Oidak District Gaming Revenue Five Month Budget amount of \$1,425,926.76; and

23 **WHEREAS,** the Budget and Finance Committee has reviewed the FY 2025 Sif-Oidak District  
24 Gaming Revenue Administration and Facility Maintenance Five Month Budget  
25 Amendment No. 1 and recommends its approval.

26 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council approves the  
27 FY 2025 Sif-Oidak District Gaming Revenue Administration and Facility  
28 Maintenance Five Month Budget Amendment No. 1 retroactive to May 1, 2025  
29 through September 30, 2025, which will not change the FY 2025 Sif-Oidak District  
30 Gaming Revenue Administration and Facility Maintenance Five Month Budget  
31 amount of \$17,512.53 nor will it change the FY 2025 Sif-Oidak District Gaming  
32 Revenue Five Month Budget amount of \$1,425,926.76.



**The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 27<sup>TH</sup> day of JUNE, 2025 at a meeting at which a quorum was present with a vote of 3,321.1 FOR; -0- AGAINST; -0- NOT VOTING; and [04] ABSENT, pursuant to the powers vested in the Council by Article IX, Section 7 of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat.984).**


