

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2026 Gu Achi District Budget)**

RESOLUTION NO. 25-184

WHEREAS, pursuant to Article IX, Section 7 of the Constitution of the Tohono O'odham Nation,

No district council shall expend district funds except pursuant to budgets authorized under resolutions of the district council and approved by the Tohono O'odham Council. The management of these funds shall be only by a treasurer or other authorized officer of the district council who has furnished a surety bond satisfactory to the treasurer of the Tohono O'odham Nation, and all expenditures of these funds shall be by checks signed by such treasurer or other authorized officer and the chairman or vice chairman of the district council.

WHEREAS, by Gu Achi District Council Resolution No. 0525-187, the Gu Achi District has authorized the FY 2026 Gu Achi District Budget, which is incorporated by this reference, in the amount of \$4,735,610.33; and

WHEREAS, the Budget and Finance Committee has reviewed the FY 2026 Gu Achi District Budget and recommends its approval.

NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the FY 2026 Gu Achi Budget effective October 1, 2025, in the amount of \$4,735,610.33, which shall be funded by the August 2025 District Gaming Allocation.

BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the FY 2026 Gu Achi District Budget shall be managed and expended in accordance with Article IX, Section 7 of the Constitution of the Tohono O'odham Nation and the Nation's laws, provided that any amendments or modifications shall be authorized under District Council resolution and submitted for prior approval by the Tohono O'odham Legislative Council.

The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 07TH day of JULY, 2025 at a meeting at which a quorum was present with a vote of 3,321.1 FOR; -0- AGAINST; -0- NOT VOTING; and -0- ABSENT, pursuant to the powers vested in the Council by Article IX, Section 7 the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat.984).
