Numbers of Enrolled Members)**

RESOLUTION NO. 25-193

1 **WHEREAS, the Tohono O'odham Legislative Council is vested with the power to enact laws**
2 **and ordinances governing the enrollment and adoption of members**
3 **(Constitution of the Tohono O'odham Nation, Article II, Sections 1 and 2 and**
4 **Article VI, Section 1(h)); and**

5 **WHEREAS, pursuant to Article VI and VII of the Nation's Enrollment Ordinance, the**
6 **Enrollment Committee shall review membership applications and make a**
7 **written recommendation to the Tohono O'odham Legislative Council to approve**
8 **or reject the application (14 Tohono O'odham Code Chapter 1 - Enrollment**
9 **Ordinance); and**

10 **WHEREAS, pursuant to Article VIII of the Nation's Enrollment Ordinance, the Tohono**
11 **O'odham Legislative Council shall determine eligibility for membership or**
12 **adoption; and**

13 **WHEREAS, the Enrollment Program has determined that a number of resolutions approving**
14 **membership and adoption applications misspelled or incorrectly listed the**
15 **names of members and/or incorrectly listed enrollment numbers; and**

16 **WHEREAS, the Enrollment Committee recommends that Resolution Nos. 114-80, 127-83, 97-**
17 **078, 09-168, 09-369, 09-330, 10-070, 11-001, 12-001, and 13-001 be amended to**
18 **reflect the correct name and/or enrollment number for the members identified**
19 **in the July 2025 Corrected Enrollment Resolution Summary, which is**
20 **incorporated by this reference.**

21 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that Resolution**
22 **Nos. 114-80, 127-83, 97-078, 09-168, 09-369, 09-330, 10-070, 11-001, 12-001, and 13-**
23 **001 are amended upon the effective date of those resolutions to reflect the correct**
24 **names and/or enrollment number of members identified in the July 2025**
25 **Corrected Enrollment Resolution Summary.**


26 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 08TH**

31 **Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section**
32 **16 of the Act of June 18, 1934 (48 Stat.984).**


