

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2025-FY 2026 Department of Education Child Care and Development
Fund Mandatory 21PCAZCCDF Carry Forward Multi-Year Budget)

RESOLUTION NO. 25-203

1 **WHEREAS,** the Tohono O'odham Legislative Council is authorized "to manage any funds
2 within the exclusive control of the Tohono O'odham Nation . . . and to appropriate
3 these funds for the benefit of the nation and its members" provided that "[a]ll
4 expenditures of these funds shall be pursuant to appropriations or budgets"
5 authorized by resolution or ordinance (Constitution of the Tohono O'odham
6 Nation, Article VI, Section 1(d)(2)); and

7 **WHEREAS,** the Department of Education has prepared and submitted for review and
8 approval its FY 2025-FY 2026 Child Care and Development Fund Mandatory
9 21PCAZCCDF Carry Forward Multi-Year Budget, which is incorporated by this
10 reference, in the amount of \$576,862.69 to be funded by the Nation's general fund
11 pending reimbursement from the Grantor, the United States Department of
12 Health and Human Services, Administration for Children and Families; and

13 **WHEREAS,** the Human Resources Development Committee and Budget and Finance
14 Committee have reviewed the FY 2025-FY 2026 Department of Education Child
15 Care and Development Fund Mandatory 21PCAZCCDF Carry Forward Multi-Year
16 Budget and recommend its approval.

17 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council approves the
18 FY 2025-FY 2026 Department of Education Child Care and Development Fund
19 Mandatory 21PCAZCCDF Carry Forward Multi-Year Budget effective October 1,
20 2024 through September 30, 2026 in amount of \$576,862.69, which shall be funded
21 by the Nation's General Fund pending reimbursement from the Grantor, the
22 United States Department of Health and Human Services, Administration for
23 Children and Families.

24 **BE IT FINALLY RESOLVED** by the Tohono O'odham Legislative Council that the Tohono O'odham
25 Nation chairperson or any designated official is authorized to administer and
26 expend the FY 2025-FY 2026 Department of Education Child Care and
27 Development Fund Mandatory 21PCAZCCDF Carry Forward Multi-Year Budget,
28 provided that any amendments or modifications shall be submitted for prior
29 approval by the Tohono O'odham Legislative Council.
